## Assembly Proceedings

The 21st annual District Assembly of the Idaho-Washington District of the Pilgrim Holiness Church convened at the Spokane Church on June 4th, 1935, with the District Superintendent Rev. E. R. Himmelright presiding.

Brother Partridge led the Assembly in singing "He Whispers His Love To Me." Brother Himmelright read from Eph. 4 and Psalms 133, after which the Assembly went to prayer for 45 minutes. Special song sung by the Goss sisters.

The Assembly ratified the action of the District Council in taking Brothers Shoemaker and Webber into the Assembly.

## Assembly Bar

Motion made that the first two front seats be reserved as the Assembly Bar. Motion supported and carried.

## Time of Sessions

The time of sessions was set from 8:30 to 11:45 a. m. and to begin at 1:30 p. m. and close at 4:30.

## Roll Call

The roll of Assembly members was prepared and called. There were 22 ministers and delegates present.

The following committees were appointed: Ways and Means, Resolutions, Statistical, Reception, Editing, and Auditing.

A motion was made that we set aside the last 45 minutes of the morning session to be given to a preaching service. Motion carried.

Sister Garner, Brother Doll and Sister Bittleston were appointed as the Devotional Committee. "He Whispers His Love To Me" was sung by the Assembly and led by Brother Shoemaker.

At 11:05 a. m. Brother Webber read from the 34th Psalm, followed by a testimony meeting.

The Reception committee introduced Sister Webber, Sister Shoemaker, Sister Cronrath, Brother Evans, Brother Scott, Sister Wells and Dorothy Bonner. They were given honorary seats in the Assembly Bar.

Assembly adjourned with prayer by Sister Garner.

## SECOND SESSION

The second session opened with the Assembly upon their knees and led in prayer by Sister Cronrath. Brother Shoemaker led us in singing, "When We All Get To Heaven" and read from the first chapter of John.

Motion made that we dispense with the roll call. Motion supported and carried.

### Resolutions

The Committee on Resolutions reported. The following resolutions were adopted:

Resolution No. 1. Resolved, that we have four prayer-conventions during the year.

Resolution No. 2. Resolved, that the time and place of prayer-con-

tions be arranged for by the Superintendent and his Assistant.

Resolution No. 3. Resolved, that 125 copies of the District Minutes be printed and one copy be placed in the hands of each Pilgrim Holiness family and minister of this District, and that five copies be mailed to the General Office and one to each District Superintendent, providing we can get reasonable prices.

Resolution No. 4. Resolved, that the District Superintendent visit all independent churches and missions of the District, which are supplied by ministers who are members of this Assembly when advisable.

Resolution No. 5. that the District Superintendent appoint the Statistical Committee two weeks prior to the Assembly, and that the Superintendent send two blank reports to each minister, church and Sunday School and that these be filled out and one copy sent to the Committee not less than ten days prior to the Assembly, and the other to be retained and read on the floor of the Assembly.

Resolution No. 6. Resolved, that each church of our District set one prayer-meeting night during each month as a special time for donations to the pastor and family, such to be announced by one of the deacons at a previous service.

Resolution No. 7. Resolved, that our church year end the last day of June, and that we have our Assembly and camp-meeting the first part of July.

Resolution No. 8. Resolved, that all lady members of the Pilgrim Holiness church of the Idaho-Washington District let their hair grow after coming to the age of 12 years.

Resolution No. 9. Resolved, that no pastor or church shall call an evangelist without the consent of the District Superintendent.

Resolution No. 10. Resolved, that no worker shall be allowed on our platforms whose practice, that is their lives and dress does not come up to our church standards.

Resolution No. 11. Resolved, that we pay our District Superintendent \$50.00 a month and traveling expenses.

Resolution No. 12. Resolved, that in as far as possible each pastor and his congregation observe a united fast and prayer service each Tuesday A. M. of each week, for the salvation of souls throughout the district and for the spiritual welfare of the church.

Resolution No. 13. Resolved, that all monies or receipts for monies sent to the different departments of the general church be given to the local church treasurer and then forwarded to the District Treasurer in order that our financial records shall be complete.

Resolution No. 14. That the Chairman of each District group-meeting appoint a reporter, who shall report the same to the Pilgrim Advocate.

Resolution No. 15. Resolved, that our District Superintendent be our Home Missionary and that he choose his helpers.

Resolution No. 16. Resolved, that the District Council serve as the Camp-meeting Committee or elect a committee if necessary.

Resolution No. 17. Resolved, that the District purchase the set of books and questions required for the Ministerial Course of study, these to be

loaned by the Educational Board as follows: Those giving the test for the First, Second and Third year.

Resolution No. 18. Resolved, that we recommend active pastors to be elected as Advisory members of the District Council.

Resolution No. 19. Resolved, that one day of each quarterly prayer convention be given to the young people of the District.

Resolution No. 20. Resolved, that we as an Assembly give a rising vote of thanks to our District Superintendent, Brother Himmelright, for his faithful and much appreciated service and labor of love.

Resolution No. 21. Resolved, that we as an Assembly give a rising vote of thanks to our District Secretary, Sister Hazel Goss, and District Treasurer, Brother Fullerton, for their faithful services.

Resolution No. 22. Resolved, that we give a rising vote of thanks to Sister Frost, our Assembly cook, for her faithful and loving services.

Resolution No. 1. Be it resolved, that each local church of the District be apportioned the minimum of \$5.00 per member to finance our general church and District obligations, said amount to be distributed as follows: Foreign Missions, 40%; District expenses, 40%; General Budget, 20%.

Resolution No. 2. Be it resolved, that all active and inactive licensed and ordained ministers and deaconesses pay at least one-half of their tithe of the remuneration received from their ministry into the local church treasury, to be forwarded to the District Treasurer to be applied on the District Superintendent's salary.

Resolution No. 3. Be it resolved, that the District Superintendent supervise all home missionary activities and unless the needs require it, that he make two visits per year to each church, and at all services conducted by him, he take offerings and pledges, the same to be applied on District expenses.

Motion made that we have election of officers the first business of the afternoon. Motion carried. Business ceased and the service turned over to devotionals.

We sang "Calvary" and had a duet by Sister Shoemaker and Sister Norris, after which Sister Hazel Goss preached on "Going Forward."

Adjourned with prayer by Brother Webster.

## SIXTH SESSION

This session opened by singing "There's Honey in the Rock," led by Brother Wells. Prayer by Brother Webber. Brother Partridge read the 12th chapter of Romans. Special song by our Deaconesses, Dorothy Bonner, Pearl Doll, Rudy Goss and Mabel Bittleston.
