Assembly called to order at 8:00 P. M. by the chairman.

Prayer by Sister Conrath and Brother Scranton. Scripture read from Thess. 1. Brother Thomas then talked to us on the subject "The Local Church."

Roll call read.

Brother and Sister Milton Schweitzer were introduced to the assembly.

Resolution committee prepared to report.

Motion made that we read all resolutions of the previous assembly minutes. Carried. The resolutions were reviewed by the assembly, some were stricken from our minutes, and other new ones were added.

R. A. Fullerton our district treasurer gave a talk to our district assembly in regard to filling out reports. Adjourned with prayer by Brother Abbott.

THIRD SITTING

Assembly came to order 9:00 A. M., Brother Thomas in the chair. Song service lead by Brother M. E. Stockman, singing "He Leadeth Me."

Psa. 91 was read as a scripture lesson by Brother Tully Abbott. While on our knees we sang "Near The Cross." We were led in prayer by Brother J. W. Partridge. Our souls were stirred as Brother Thomas talked to us on "Cooperation in the Kingdom of God."

Motion was made to dispense with the roll call. Carried.

Previous minutes read, corrected and accepted.

The auditing committee gave its report which was accepted.

The treasurer's report was read and accepted.

Sister Lawson Flora was introduced to the assembly and granted an honorary seat in the assembly bar.

The statistical committee gave its report which was referred back for re-checking.

A number of resolutions were presented at this time by the ways and means committee.

The chairman gave a talk on the missionary offering.

Dismissed with prayer by Brother Tromble.

FOURTH SITTING

Assembly came to order at 2:00 P. M., Brother Thomas presiding. Scripture read from Psalms 103 by Brother M. E. Stockman. Lead in prayer by Brother Tully Abbott.

The resolution committee presented more resolutions at this time.

The following names, having been passed on by the examining board and the district council, were presented to the assembly for approval. A motion was made to vote on the names collectively.

J. W. Partridge for renewal of license and advancement to third year of course of study. Mrs. Alice Norris for renewal of license and advancement to the third year course of study. Tully Abbott admitted to the district and granted renewal of license. Carl Bennett granted renewal of license and advanced to third year of course of study. Lawson H. Flora for renewal of license. Mrs. Elizabeth Woods for renewal of license and retained in first year course of study. M. H. Schweitzer admitted to the district as an ordained minister. M. E. Stockman admitted to the district as an ordained minister. Kathleen Carter for renewal of license and retained in the second year course of study. Mabel Bittleston for renewal of license. Mrs. Rachel Stockman admitted to the district and renewal of license in the second year course of study.

Motion made to accept these as presented. Carried.

Motion that the chairman appoint two tellers for the election of officers. Brothers Stanley Weber and J. W. Partridge were appointed. The assembly looked to the Lord in prayer for Divine help and guidance in this election.

Motion made and carried that the district superintendent appoint two members for the editing committee, subject to the approval of the assembly. Ralph Tromble and M. E. Stockman were appointed. Appointments were ratified by the assembly.

When business was resumed the ways and means committee presented additional resolutions which were accepted.

Moved and carried to receive the corrected statistical report.

Moved that the district superintendent appoint the statician for the coming year. Carried.

Additional resolutions were prestend by the resolution committee and were accepted.

Sister Felthouse and Sister McCracken were introduced to the assembly.

Motion made that the district council work out a plan for the expense of delegates to the General Assembly and notify the churches of their plan. Carried.

Minutes today's settings were read, corrected and approved.

Moved to adjourn. Carried.

Adjourned by singing "Blest Be The Tie That Binds," and prayer by Brother Himmelright.

Resolutions

The following resolutions were presented by the resolution committee and adopted by the assembly:

1. Resolved, that we have two prayer conventions during the year.
2. Resolved, that the time and place of the prayer conventions be arranged for by the superintendent and his assistant.
3. Resolved, that 150 copies of the district minutes be printed and one copy be placed in the hands of each Pilgrim Holiness family and minister of this district, and that five copies be mailed to the general office, and one to each district superintendent.

4. Resolved, that the District Superintendent appoint the statistical committee two weeks prior to the assembly, and that the superintendent send two blank reports to each minister, church, and Sunday school, and that these be filled out and one copy sent to the committee not less than ten days prior to the assembly, and the other be retained and read on the floor of the assembly.

5. Resolved, that each church of our district set one prayer-meeting night during each month as a special time for donations to the pastor and family, such to be announced by one of the deacons at a previous service.

6. Resolved, that the camp and assembly be held the last week of July and the first week of August, or as near this date as possible.

7. Resolved, that all parent members of the Pilgrim Holiness Church refrain from cutting their girls hair, and that they dress them as becometh Holiness.

8. Resolved, that no pastor or church call an evangelist without the consent of the district superintendent.

9. Resolved, that no worker shall be allowed on our platforms, whose practice, that is their lives and dress, does not come up to our church standards.

10. Resolved, that our district superintendent be our home missionary and that he choose his helpers.

11. Resolved, that our district council serve as the camp meeting committee, or elect a committee if necessary.

12. Resolved, that we recommend active pastors to be elected as advisory members of the district council.

13. Resolved, that one afternoon of each prayer convention be given to the young people of the district.

14. Resolved, that the superintendent instruct the deacons of their duty and that they give a written report each quarter.

15. Resolved, that each pastor preach or at least touch definitely on tithing, at least twice a year.

16. Resolved, that in as much as we are living in such times of worldliness, we, the assembly, deem it the duty of the parents, to see to it that their children do not dress improperly; such as boys without shirts, girls without stockings, and in pajamas and slacks.

17. Resolved, that we send a letter to Brother Wilson, expressing our love and friendship.

18. Resolved, that a letter of love and sympathy be sent to Brother Surbrook in this time of sadness, caused by a death in the family.

19. Resolved, that each church have a uniform treasurer's book to keep accurate accounts.

20. Resolved, that we express our appreciation to Brother Thomas for coming so far across the country to be with us, and help us in this time of need.

21. Resolved, that we express our appreciation to our district superintendent, secretary, and treasurer for their services during the past year.

Ways and Means

1. Be it resolved, that each local church of the district be apportioned the minimum of five dollars per member to finance our general church and district obligations. Said amount to be distributed as follows: foreign missionaries, \$2.00; district expense, \$2.00; general budget, \$1.00.

2. Be it resolved, that all active and inactive licensed and ordained deaconesses pay the tithe of the remuneration received from their ministry into the local church treasury, to be forwarded to the district treasurer to be applied on the district superintendent's salary.

3. Be it resolved, that each church take a missionary offering each month.

4. Be it resolved, that we pay our district superintendent at least \$55.00 per month and traveling expenses.
