MINUTES OF THE EIGHTH ANNUAL CONFERENCE
OF THE
SOUTH CAROLINA DISTRICT

The Eighth Annual Conference of the South Carolina District convened at the District Camp Dormitory, Winnsboro, South Carolina, on September 1, 1949. Conference was opened at 9:00 a.m. by the District Superintendent, Rev. M. T. Cockman, who asked the McCombs to have charge of the song service. Brother McCombs then led us in the grand old hymn, "Where He Leads Me I Will Follow", with Sister McCombs at the piano.

Brother Cockman gave a short exhortation and asked Rev. J. H. Ellenberg to lead us in prayer. After prayer Brother Cockman presented Rev. R. A. Beltz, General Secretary of Home Missions, as the presiding officer of the conference.

Brother Beltz gave us a very timely message, reading for the scripture lesson John 2:1-11. He used as his text the words of our Lord's mother, "Whatsoever he saith unto you do it." The theme, "Miracles of Obedience."

The secretary then called the roll and Brother Beltz requested that all present sit within the conference bar.

Rev. A. E. Barefoot, Jr., an ordained minister from the North Carolina District, was received into the South Carolina District Conference by a letter of transfer.

The District Superintendent read his report, which was accepted.

Brother Cockman gave a report of the progress of the new church at Columbia. Moved and seconded that the First Pilgrim Holiness Church of Columbia be received into the conference.

The District Treasurer's report was read and accepted.

The Statistical report was read and accepted.

The Ways and Means Committee reported as follows:

Be it resolved that Brother Cockman, on his first visit to the churches, receive an offering to help defray the expenses of the delegates to General Conference next June. Carried.

The Resolution Committee reported as follows:

Be it resolved that the South Carolina District Camp will have a camp secretary-treasurer, the same to be appointed by the District Council. Carried.

Be it therefore resolved that the South Carolina District change their present camp date to a convenient date in June.

Amendment of the standing rule no. 9.

Be it resolved that the district council shall set the date for the closing of the church year to correspond with the new date of the camp and conference. Carried.

A motion made and carried at 11:45 to adjourn and reconvene at 2:00 p.m.

The minutes of the previous sitting were read and accepted.

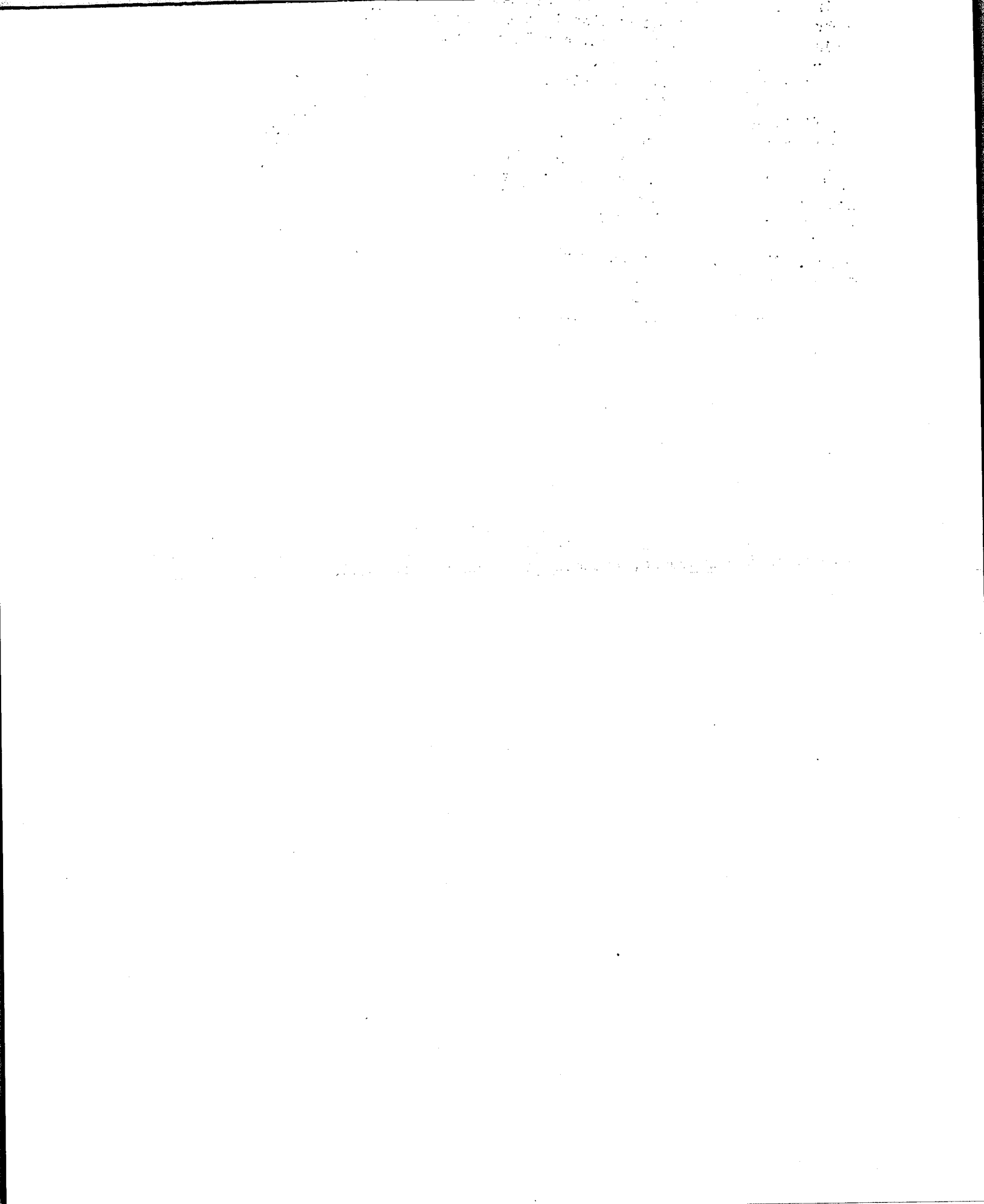
Brother Beltz brought us a splendid and inspiring message. His subject, "Getting Things Done", was a real encouragement to all.

DISTRICT SUPERINTENDENT'S REPORT

September 1, 1949

To the Reverend R. A. Beltz, General Secretary of Home Missions, and the Eighth Annual Conference of the South Carolina District of the Pilgrim Holiness Church,

Greetings!

This has been the busiest year of my life. I am indeed grateful to God that I can report present victory in my soul and that it has been one of the best years of my ministry. It is with deep gratefulness to God for these manifest favors that I present this report of the work which God and the Department of Home Missions of the Pilgrim Holiness Church have entrusted to my oversight during the past year.

We appreciate very much the cooperation and encouragement we have received from the Department of Home Missions and the ministers and members of the South Carolina District, as we have endeavored to carry out God's plan in regards to the District work.

We hereby submit the following report:

We have visited all the churches three times and some of them more. We have found the spiritual tide of the churches rising, souls praying through, interest on the increase, pastors and people encouraged.

Along with our District duties we were permitted according to our contract of September 15, 1948, to finish our school work at Taylor University, Upland, Indiana. We visited the field three times before moving June 6, 1949. Due to this fact we have not been able to accomplish the work which we would liked to have soon completed.

We attended the meeting of the board of directors of the Pilgrim Bible Collogo, Kernersville, North Carolina.

We have conducted three revivals, and some week-end meetings. Sermons preached, 85; members received into the church, 7.

My salary is paid in full to date from the Department of General Home Missions.

We are happy to present to the conference the First Pilgrim Holiness Church of Columbia, South Carolina, at the request of the chair. There is an open door in this great southern state for the Pilgrim Holiness Church. By God's grace and help we expect in the coming months and years, if God tarries in His coming, to see many Pilgrim Holiness Churches throughout this state. My motto is:

STANDING RULES

1. The District Council shall set the date of the District camp and conference and call the workers.
2. The District Council shall select the date and place for the Ministerial Convention.
3. There shall be a District Camp Meeting Association with dues of one dollar per member each year, money to be used in promoting the annual Camp.
4. All licensed and ordained ministers shall tithe the income of their ministerial labors into the district treasury for the support of the District Superintendent.
5. The churches shall raise the following amount each month toward the support of the District Superintendent.

Winnsboro	\$3.00	Killian	\$3.00
Columbia	3.00	Lugoff	3.00

In addition to these amounts each church shall take a free-will offering for the Superintendent on each of his visits to apply on his traveling expenses.
6. The District Superintendent's salary from the District shall be \$50.00 a month, same to be paid from the ministerial tithe and the monthly apportionment to the churches.
7. The Sunday School offerings on the fifth Sunday shall be sent to the District Treasurer for miscellaneous District expense. We urge the churches to make this a generous offering each quarter.
8. All District funds shall be forwarded to the District Treasurer on or before the tenth of each month.
9. All church books and records shall be closed April 30th and reports prepared for the annual District Conference. The statistical reports shall be sent immediately after this date to the District Secretary.
10. Each minister on the District shall contribute at least one week's work on the camp ground each, subject to the call of the District Superintendent.
11. Each pastor shall be expected to attend the Camp and Conference and remain until the cleaning up is finished, unless excused by the District Council.
12. The District Young People's work shall be under the supervision of the District Superintendent. There shall be a Young People's Convention held in connection with the annual Camp.
13. BE IT RESOLVED: That the week preceding Easter be a week of self-denial for the benefit of a great Easter offering for Home Missions.
