## Proceedings

The Twentieth Annual Conference of the Ontario District of The Pilgrim Holiness Church convened 10:00 a.m. Friday, September 7th, 1915, in the Pilgrim Holiness Mission at Oshawa, Ontario.

The First Session opened by the singing of: "When I Survey The Wondrous Cross" led by Brother Robert Gordon. Brother Gerald Beckwith, and Sister Gordon led in prayer.

Brother Frank Hobbs, the District Superintendent, brought a soul-inspiring message from the word. He read Exodus 14: 1-20, 30, 31; using verse 15 as a basis for his remarks.

At the close of the devotional period, Brother Hobbs appointed the various committees, Brother Weaver, fraternal delegate from the Wesleyan Methodist Church, was introduced, and gave a brief word of testimony.

The Conference agreed to recess until 2:30 p.m. to await the arrival of Brothers R. W. Wolfe and E. O. Howell, Home-Missionary Secretary, and representative.

It was agreed to adopt the same business hours as last year: Morning Sitting: 9:00 a.m. to 11:30 a.m. Afternoon Sitting: 2:30 p.m. to 5:30 p.m. Moved and seconded we recess.—Carried.

### SECOND SESSION

The afternoon session convened at 2:30 p.m.

Previous to the arrival of our Home Missionary representatives, Brother Hobbs, District Superintendent, introduced the fraternal delegate from the Free Methodist Church, Rev. Barclay Warren, who brought fraternal greetings from his Conference. He also spoke briefly on the subject of unity and fellowship among the holiness denominations, and gave a good report of the recent Canadian Holiness Federation meeting at Ottawa, Ont.

Brother F. Hobbs replied with fitting words.

Brother Robert Gordon reported on his trip to Frankford as fraternal delegate to the Free Methodist Conference.

At this point Brothers R. W. Wolfe, and E. O. Howell arrived.

Brother F. Hobbs introduced Brother Wolfe to the Conference. Brother Wolfe explained his delayed arrival to the Conference.

Brother Wolfe introduced Brother E. O. Howell, who gave a few brief words of testimony.

Brother Wolfe called for a few minutes recess to prepare for business. This was granted. The Conference recessed.

Brother Wolfe called the Conference to order taking the Chair. Brother F. Hobbs introduced Brother Weaver, fraternal delegate from the Wesleyan Methodist Conference. He brought fraternal greetings from his Conference.

Brother Weaver asked Brother Warren to sing "Deeper than the stain has gone". This message in song was blessed to the Conference.

The first five seats were chosen to constitute the Conference bar.

Brother Wolfe then introduced Brothers E. O. Howell, Barclay Warren, and Brother Weaver. All testified briefly.

Sister Grace Kellaway, Brother Russell Barkman, and Gerald Beckwith, the new pastors, were received as members of the Ontario District.

The reports of the pastors and delegates were received and accepted.

The District Superintendent read his report of the past year. The report was accepted.

The District Statistician read her report. The report was accepted.

The Resolutions Committee reported.

It was moved and seconded that standing Resolution No. 9 be deleted from the Minutes.—Carried.

Moved and seconded that Standing Resolution No. 10 be deleted from the Minutes.—Carried.

The Conference adjourned.

### THIRD SESSION

Business commenced at 10:30 a.m.

The devotional service proceeded by the singing of hymns, and the offering of prayer. A number testified.

Brother White addressed the Conference bringing a stirring message from Ephesians 3: 1-8.

The Conference was called to order. The Minutes of the two previous sittings were read and approved.

The Resolutions Committee reported.

Resolution No. 1 was accepted.

Resolution No. 2 was accepted.

Resolution No. 3 was accepted.

Resolution No. 4 was accepted.

The Conference recessed until the afternoon sitting.

### FOURTH SESSION

Brother H. W. Hobbs led in prayer.

The report of the District Treasurer was read and accepted.

The report of the Auditors was read and accepted.

The Resolutions Committee brought a final report.

The Ways and Means Committee reported.

Resolution No. 1 was accepted.

Resolution No. 2 was accepted.

The combined report of the Educational and Examining Boards was read and accepted.

The District Sunday School Committee report was given orally by Sister Florence Hobbs. The report was accepted.

The Conference elected Brother H. W. Hobbs, president of the Pilgrim Bible College. In accordance with the Manual, it was agreed to elect a Bible School Board. Brother Harold Hobbs was chosen as chairman of said Board, Sister Gladys White, Secretary, and Brother E. G. Rossiter lay-member.

Elected as delegates to the General Conference of 1946 were the following: Ministerial, Brother Wesley Bray, and Sister Mae Cornfield. Alternate G. Beckwith, Lay-member E. G. Rossiter, alternate Sister Wesley Bray.

The Committee on Memorials brought in one memorial. It was carried.

The District Trustees were re-elected by acclamation.

Moved and seconded the District Council appoint the fraternal delegates to the Free Methodist and Wesleyan Methodist Conferences.—Carried.

On motion the District Superintendent named the new members of the Educational and Examining Boards.

Brother Bray was chosen for the Examining Board; Sister Kellaway for the Educational Board.

It was moved and seconded that Sisters R. Gordon, F. Hobbs, and G. Kellaway act as the District Sunday School Committee.—Carried.

Moved and seconded that the District Statistician and Auditors be appointed by the District Council.—Carried.

It was moved and seconded that the District Council decide the date of the 1946 Camp-Meeting and Conference.—Carried.

Upon nomination by the Superintendent, Brother Wolfe appointed Wesley Bray to the District Council, as advisory member to replace H. W. Hobbs.

Upon nomination by the Superintendent, Brother Wolfe appointed Gladys White District Secretary.

Moved and seconded that the District Council read and approve the minutes of the last two sessions of the Conference.—Carried.

Moved and seconded that the District Council take care of any unfinished business of this Conference.—Carried.

Moved and seconded we adjourn.—Carried.

Brother E. O. Howell dismissed by prayer.

## *Reports*

### DISTRICT SUPERINTENDENT'S REPORT

To the Ontario Conference of the Pilgrim Holiness Church in session at the Pilgrim Mission, 74 Athol St., W., Oshawa. Greetings!

It is indeed with a grateful heart we come to our first peace-time Conference after six bloody years of bloodshed and strife. Although our world presents so many challenges to a lasting peace, we cannot but thank God for the end of hostilities in Europe and Asia.

The year has sped by rapidly and each day has brought its own problems and battles. In and through all we are happy to report personal victory through the blood of our Lord Jesus Christ.

We had hoped, in the beginning of the year to have time, being released from a pastorate, to devote to new work. However a number of emergencies have arisen which have made it necessary for us to supply vacancies in our present fields.

We visited the churches at least twice during the year, and mostly several times.

Our Massey Church has witnessed a gracious outpouring of God's blessing, under the capable leadership of Sister Grace Kellaway. The Church enjoyed a real spiritual reviving, when seventeen seekers sought during a revival meeting. The Church is gaining, and we look for greater blessings still in the work here.

We were privileged to give some time to the Church at Massey in assisting to put a new roof on the parsonage.

Our work at Lion's Head has been owned of God. We enjoyed the privilege of being with the saints there for a revival meeting during the year.

The Church at Toronto has had a rather trying year, but God is encouraging hearts, and we feel God has enabled us to find a pastor to fill the vacancy here.

The Proton Church has grown spiritually under Brother Gordon's ministry, as well as the Oshawa work under Brother H. W. Hobbs.

God has been laying upon our hearts the re-opening of our Bible School, and, during a good Camp Meeting we were able to raise \$1,000.00 toward this work.

Our people are definitely taking this upon their hearts, and we propose, subject to the approval of the General Board, to re-open the School not later than the fall of 1946.

During the year we preached 96 times; conducted one funeral; held one revival on the district, and one off; had 19 seekers for regeneration and 2 for sanctification; conducted 10 business meetings and held the Annual Meetings.

We travelled 10,000 miles in the interest of the district. Our support as Superintendent was \$2,400.00 and \$288.43 travelling expense from the District.

**Memorial No. 2**—Whereas the members of our Church are going to other denominations for the rite of baptism; be it resolved that our ministry emphasize and practise believers' baptism.

## *Standing Resolutions*

1. Resolved that our Pastors' tithes be allocated to District Home Missions.

2. Resolved that the District Council appoint an editing committee to continue the mimeographing of the District paper. That said paper be published monthly.

3. Resolved that all unstationed ministers, licensed ministers and deaconesses pay at least half their tithe to the District Secretary-Treasurer to be used at the discretion of the District Council.

4. Be it resolved, we as a District, take care of our Superintendent's travelling expense.

5. Resolved that our Budgets for new year be \$5.00 a member, to be divided as follows: General Budget \$1.50; District Budget, \$3.50.

6. Resolved that our preachers preach at least one sermon each quarter on Scriptural giving.

7. Resolved that local church shall take up a special offering previous to our Camp Meeting, for the support of pastor and delegate during Camp and Conference.

8. Be it resolved that we have a registration fee of \$1.00 for ministers and delegates to be paid on registering at opening of Conference. This fee shall be used to defray expenses of Conference.

9. Be it resolved that the District Council appoint a Camp Meeting Secretary-Treasurer whose duties shall be to take care of all correspondence and publicity for the Camp; also to receive and disburse all funds of the Camp, keeping a complete record of the same.

10. Resolved that all stationed preachers come, send someone or pay the equivalent of two days' labour for the preparation of the District Camp and Conference, when called upon by District Superintendent.

11. Whereas the Examining and Educational Committees have difficulty in proceeding with their work without sufficiently clear information from licentiates as to their progress in grace and the course of study; be it resolved that our pastors shall advise all licentiates to write to the Chairman of the Educational and Examining Boards previous to Conference stating their progress in studies and grace; failing to do so these Committees shall not be obliged to renew any license.

12. Resolved that twenty-five cents be placed as the fee for each examination of the Study Courses plus expense of postage and questions.

13. Resolved that each local church shall supply the parsonage with stove, chairs, table and dresser.

14. Considering the importance of Sunday School work relative to the future, be it resolved that this Conference elect a District committee comprising three members. Be it further resolved that the committee use one page monthly in our District paper to further Sunday School interests.

15. Resolved that each local church observe the sacrament of the Lord's supper at least once each quarter.

16. Whereas Missionary vision and prayer are of even more vital necessity than the raising of finances, and are an aid to the raising of the same, and whereas information and inspiration are indispensable to that end, we recommend that our pastors diligently continue the monthly Missionary meetings, alternating for Home and Foreign Missions as hitherto.

17. Resolved that our Superintendent and District Council comprise our District Home Missionary Committee.

18. Whereas, there is a need of a reserve tent fund, be it therefore resolved that it consist of one half of the Birthday offerings and also a weekly offering from the Sunday Schools, the amount to be decided by the Pastor and the Sunday School Board.

19. Resolved that all money raised for District and General funds shall be forwarded to District Secretary-Treasurer at the end of each month.

20. Resolved that a remuneration of \$10.00 per annum be paid to the District Secretary-Treasurer.

21. Resolved that before calling any Evangelist, the pastors shall consult with and act on the advise of the District Superintendent.
