CONFERENCE PROCEEDINGS

First Session

The Forty-first Annual Conference of the Pilgrim Holiness Church of Canada convened at the Toronto Church on July 1, 1966, at 9:00 a.m. The Conference joined in the singing of one of the hymns of Christendom, "I Need Thee Every Hour." The host Pastor, Rev. Frank Evans, led the congregation in prayer.

The District Superintendent introduced General Superintendent Paul F. Elliott, who brought greetings from the General Church. Bro Elliott then read from the hymn, "Breathe on me, Breath of God," and John 20: 21—22, his theme being "The Breath of God," in which he pointed out that Jesus breathed on, in and out of His disciples.

The Chairman then called for the reading of the roll.

A motion prevailed that Bro. Roy Brunson be seated in the Conference as the delegate from Dyer's Bay.

It was moved that the first five rows and platform be considered the Conference bar. This motion was seconded and carried.

It was moved that the Conference sessions be as follows: 9—11:45 a.m.; 2:00 p.m. to the completion of business or 5:00 p.m., and that any unfinished business be turned over to the Council for completion. This motion was seconded and carried.

A motion prevailed that the District Missionary President be seated in the bar.

The Chair then called for the report of the D. S. This report was received. A motion was made that the recommendation contained therein be sent to the Steering Committee for presentation to the Conference. Seconded. Carried.

The reports of the Assistant Superintendent and Treasurer were presented and the Assistant Superintendent's report was received.

Motion prevailed that only the totals of the Statistician's report be read. This report was read and accepted.

Rev. T. L. Willingham presented Rev. Wingrove Taylor to the Conference. Bro. Taylor brought greetings from the Caribbean Bible School.

A motion was presented that Bro. Taylor be granted an honorary seat within the bar. Carried.

The Chair called for the report of the Steering Committee.

Be it resolved: that we receive two special offerings during the Church year to be known as "Quarter Day offerings." One offering to be devoted to youth interests in the District, to be received during National Youth Week. The other offering to be devoted to the District Sunday School interests, to be received the Sunday preceding Rally Day. It was moved that the motion be amended to read, 'that the Quarter Day offering for youth be taken in the regular church service.' A motion prevailed that the amendment be amended to read that the local churches exercise their choice as to where this offering is to be received. The motion, as amended, carried.

Be it resolved: that a special Home Missionary offering be received at Camp, to be used according to the advice of the District Council. Carried.

Be it resolved: that each church raise the equivalent of \$1.00 per member each year in order to set up an International Delegates' Fund, and that the balance needed be taken from the special offering taken up at the annual District Camp Meeting. Carried.

Be it resolved: that Standing Resolution No. 4 of the 1965 Conference Journal be deleted. Carried.

Be it resolved: that Standing Resolution No. 9 of the 1965 Conference Journal be amended to read, 'that 200 copies of the Journal be printed and published . . .' Carried.

The Chair called for the report of the Sunday School Promotional Secretary, which was received.

Motion prevailed that the Conference give special congratulations to the Ferndale and Toronto churches for their Sunday School achievements. Carried.

At the call of the Chair Sis. Gladys White presented the report of the Memoirs Commit-

tee. The Conference stood in silent prayer in honour of the departed, after which Dr. Elliott led in prayer.

It was moved that a secret ballot taken on the question of the location of the 1967 Annual Conference. Seconded. Carried.

A motion prevailed that a plurality vote determine the place of Conference.

The balloting resulted in the selection of Ferndale.

Motion carried that the Conference adjourn.

Second Session

The second session of the Forty-first Annual Conference convened at 2:00 p.m. Rev. Spearman led the congregation in prayer. Rev. Wingrove Taylor rendered a message in song, "I am not Worthy."

Rev. Ira Taylor was presented to the Conference.

Motion prevailed that Rev. and Mrs. Spearman and Rev. Ira Taylor be granted honorary seats within the bar.

Rev. Spearman brought fraternal greetings from the Wesleyan Methodist Church.

The minutes of the previous session were read and approved.

The Chair called for the auditor's report, which was accepted.

Motion carried that the Treasurer's report be accepted as read.

It was moved that the District Superintendent be allowed a parsonage allowance of \$15.00 per month. Seconded. Carried.

It was moved and seconded that a minimum of \$50.00 per week, plus parsonage and utilities be paid the Pastors of this District, and that if it is necessary, that the Pastor be allowed to work to make it up to \$50.00 per week plus \$5.00 per child by holding meetings or manual labour. Motion carried that the above be amended to read, that the churches have as a goal a minimum of \$50.00 per week. The motion carried as amended.

The Chair called for the elections.

Motion prevailed that we vote on the two names receiving the highest vote for Assistant Superintendent.

Motion carried that there be an open ballot.

Moved and seconded that in view of the deadlock in voting, we proceed with the other elections and return to the office of Assistant Superintendent later. Carried.

Rev. R. W. Williams was elected as District Secretary.

Miss E. Baker was elected as District Treasurer.

Rev. T. L. Willingham, Mr. Wm. Bowden, and Dr. Ivan Jackson were elected to the District Council as Advisory Members.

Motion carried that the one receiving the second highest vote be secretary, third highest, treasurer, and the two remaining nominees be advisory members of the District Missionary Board.

The balloting resulted as follows: Mrs. B. Nixon, President; Mrs. E. R. Willingham, Secretary; Mrs. R. Brunson, Treasurer; Mrs. Mayers and Mrs. L. M. Williams as Advisory members of the District Missionary Board.

Rev. Nixon was unanimously elected to the office of a District Trustee for a three-year term.

Rev. Willingham was elected to the Examining and Educational Board for a three-year term.

The District Superintendent, Rev. L. B. Reese, made the following appointments:

STEERING COMMITTEE: Rev. R. W. Williams, Rev. N. E. Nixon, Rev. T. L. Willingham, Rev. G. L. Harding, and Mr. W. Bowden.

CAMP BOARD: District Officers.

MEMOIRS: Miss Gladys White.

RECEPTION COMMITTEE: Rev. G. L. Harding.

EDITOR: Rev. R. W. Williams.

STATISTICIAN: Mrs. R. Brunson.

A motion prevailed that, inasmuch as the Conference voted twenty-eight times with no election to the office of Assistant Superintendent, let there be an additional advisory member be elected to the District Council; and that if the need of a replacement of the District Super-

intendent arises, we request the Executive of the General Church to appoint a Superintendent. Rev. N. E. Nixon was elected as an advisory member of the Council.

Motion carried that inasmuch as the Toronto Pilgrim Holiness Church is at present engaged in a revival effort, and have so kindly made provision for this Conference, Be it Resolved, that we express our sincere gratitude to the host Pastor and people for their kind services at this time.

Motion prevailed that we express our thanks to General Superintendent Paul F. Elliott for his counsel and presence in our midst.

A motion for adjournment was entertained by the Chair, and the Conference closed as Dr. Elliott pronounced the benediction.

STEERING COMMITTEE

RESOLUTION No. 5 — Be it resolved that Standing Resolution No. 9 of the 1965 Conference Journal be amended to read, 'that 200 copies of the Journal be printed and published . . .' Carried.

RESOLUTION No. 6 — It was moved that the District Superintendent be allowed a parsonage allowance of \$15.00 per month. Seconded. Carried.

RESOLUTION No. 7 — It was moved and seconded that a minimum of \$50.00 per week, plus parsonage and utilities be paid the Pastors of this District, and that if it is necessary, that the Pastor be allowed to work to make it up to \$50.00 per week plus \$5.00 per child by holding meetings or manual labour. Motion carried that the above be amended to read, that the churches have as a goal a minimum of \$50.00 per week. The motion carried as amended.

STANDING RESOLUTIONS

1. That the district treasurer shall close his books for the year as of May 31, and that pastors and local treasurers shall have a grace period of 15 days in which to ensure that all monies received in the conference year shall be in the treasurer's hands to be credited as received at that date.
2. Be it resolved that local treasurers send monthly remittances to the district treasurer by the fifth (5) of each month.
3. Be it resolved that the annual conference convene on the first Friday of July at 9:00 a.m., subject to the stipulations of the Manual.
4. Whereas there has been some misunderstanding with regards to improvements to local church property, and
Whereas the District has been obligated beyond its means in times past, Be it therefore resolved that no local church involve itself beyond \$500.00 in improvements without the consent of the District Council, and under no circumstances shall the local church involve the District in bearing the expense of local improvements.
5. Be it resolved that all the District Sunday Schools use the Royal Sunday School Record

- book for the secretary's weekly records of the Sunday school.
6. That each local church supply the parsonage with adequate heating and cooking equipment.
 7. That each pastor and the District Superintendent be granted a two-weeks' vacation including Sundays with pay. Pastors who are not on stated salaries shall receive their vacation pay and Camp-meeting Sunday offerings equal to their average weekly offering.
 8. That two hundred (200) copies of the Journal be printed and distributed, cost of same to be met from District Administration.
 9. That the District Council act as a District Church Extension Committee and have full authority to appoint Home Missionary Pastors, and to select and build on new locations.
 10. Be it resolved that the District Superintendent shall appoint the committees that are to function during the ensuing year.
 11. Whereas Dominion and Provincial laws require us to have a head office in order to operate under our charter, be it resolved that such office be located at 312 Oakwood Avenue, Toronto, Ontario, and that the District Superintendent act as manager of such office.
 12. That the District publish a paper in the interest of the Churches; said paper to be known as the "Sentinel"; to be published monthly, at the subscription rate of \$1.00 per annum.
 13. That the District Conference Journal record the number of "Sentinel" subscriptions from each local Church.

REPORT OF THE SUPERINTENDENT

To the members of the Forty-first Annual Conference of the Pilgrim Holiness Church of Canada, and to General Superintendent, P. F. Elliott, greetings.

It is with joy that I make this report to the Conference of the Pilgrim Holiness Church of Canada. The delight of working in the church one loves and appreciates is difficult to express in full. I can say without reserve that my love for God and His people deepens with the passing of the years.

This past year has been one of busy occupation in the work of the Lord. The following labors have consumed my time as your superintendent on the District, and in relation to the work of the district:

- (1) Travelled approximately 12,150 miles.
- (2) Preached 47 times on the district.
- (3) Gave Bible studies at our Camp, and also conducted one Short Course.
- (4) Conducted annual church meetings.
- (5) Attended an area meeting at Washington, D.C., and the Church Leaders' Conference in Indianapolis.
- (6) Attended District Conference and Ministerial; several Council meetings; served as fraternal delegate to the Wesleyan Methodist Conference at Silver Lake; attended Eastern Pilgrim College board meetings; and
- (7) In addition, spoke in two Ministerials and conducted three revivals off the district.

The future for the work in Canada is rather involved. We need to remind ourselves of some things, and to look earnestly at some of the future needs.

(1) We have moved slowly in view of the need of strengthening existing churches. This has been especially true with respect to finance and numerical growth. In assessing this problem in a realistic manner, we must realize that unless our pastors have adequate salaries, we cannot move ahead as we should. No man can give himself to his work and be constantly plagued with an economy which threatens his home — the "wolf" is not driven from the door simply by disregarding his presence.

A recent report from the Dominion Bureau of Statistics throws light on this problem, to wit:

"You may be surprised to learn that the dollar has lost more than 30 cents in spending power since 1949. Or that it takes a full dollar today to buy what you could get for 37½ cents before the Second World War. These computations are the result of the latest price indexes reported yesterday by the Dominion Bureau of Statistics. The consumer price

index based on 1949 consumer prices equalling 100 rose to 143.4 for May from 143.2 in April. That means that last month it cost \$14.34 to buy what \$10 bought in 1949. Or \$1 today is the equivalent in purchasing power of 69 cents 17 years ago. The price index of 30 most-used industrial raw materials, which dates from the pre-war years of 1935-39, taken as equalling 100, was 266.2 last month. That means it takes \$26.62. to buy what \$10 would buy in the years before the war. Of course, while spending more, most Canadians are making more money too."

The above statements have a vital relation to our pastors. It is true that "most Canadians are making more money too," but it is also true that this is not the case with the average pastor on our district. The salaries of some of our pastors are the same or less than they were in 1949, the comparative year of the above quoted report. Why?

In viewing these facts, the following proposal is offered for adoption by this Conference as an equitable goal toward which, as a minimum, we should strive:

"Be it resolved: that we urge all churches to support their pastors comparable to the demands and economy of the times.

"We recommend that a minimum of \$50.00 per week plus parsonage and utilities be paid the pastors of this district, and that \$5.00 per week be allowed for each child of the pastor above the minimum of \$50.00 per week. We further recommend that if the church cannot pay the above amount, pastors shall be allowed to accept meetings or manual labor to further assist their income to meet the above named figure."

(2) Your superintendent is fully aware that we are not moving very rapidly toward new fields, but it is my conviction that our need is for men of ability who are able to meet the problems of Home Mission fields. The fields are ripe, but where are the laborers? If we strengthen our existing churches and push into new fields, our subsidy for this must not depend on existing tangible sources. "Our help cometh from the Lord." "Thrust-out labourers" are the only effectual labourers. It is my prayer that God will give us men who will dare to venture. Great enterprises demand great faith.

(3) Revival is the crying need of our district. We face some critical problems, but the solution of these in God's way will give us the revival we need, I am sure. If we obey God rather than man, we need not fear the future.

"Let us then be up and doing,
With a heart for any fate."

Sunday School sessions were conducted at the Camp Meeting, and the offerings were used for promotional work.

A Sunday School Corner has been maintained in the Sentinel to keep our people informed and alert to Sunday School issues.

Our District participated in the March to Sunday School in March campaign. We congratulate Toronto for placing third in category "D" for the entire denomination, and receiving recognition in the Advocate. At this time also, Ferndale had 163 in attendance, which broke all known attendance records. Congratulations to Ferndale.

Rev. Ted Willingham taught a PELT class during Camp Meeting, with 12 persons receiving certificates for successful completion of the course. He also taught a PELT class at Ferndale, with six receiving certificates.

Some of our promotional funds were used to send Rev. Willingham and Rev. Harding to a Camp Conference in Pennsylvania, where they received valuable instruction in camp techniques.

This year, the Sunday School Committee was converted into the District Sunday School Board, and during the Ministerial Convention this Board met and organized for future activities.
