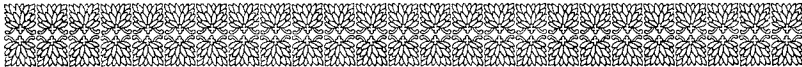

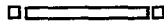

Moved and supported that C. W. McCarty consult the donors on permanent Camp fund for Nebraska as to what disposition they wish made of the fund.

Motion carried that the matter of delegates to the General Assembly be left to the District Council for appointment.

Moved and carried that the District Superintendent appoint an editorial committee to assist the Secretary in preparing the District minutes for publication.

Moved and supported that the publication committee set a price on the minutes and that each pastor consult with his Church and order the needed copies.

Motion carried that the District Council elect or appoint an Educational Board.

**REPORT OF WAYS AND MEANS COMMITTEE**

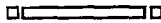
1. We recommend that the District Treasurer be paid the sum of \$25.00 for his labors, plus his expense for stationery, stamps, etc.
2. We recommend that the District Secretary be paid the sum of \$25.00 for his labors, plus his expenditures for stationery, stamps, etc.
3. We recommend that the amount paid to evangelists be decided upon by the local advisory board at the time of his service.
4. We recommend that all District monies be paid monthly through the local treasury.
5. We recommend that we continue our present financial plan in this District until our next regular or called Assembly.
6. We recommend that this District purchase a good second hand portable typewriter for District Secretary's use, the same to be District property.
7. We recommend that this District pay one-half of the actual transportation expense of the delegates to the General Assembly, after said expense has been equalized by the General Assembly.

**RESOLUTIONS PASSED AT THIS ASSEMBLY**

1. That the District Superintendent be given a salary of \$1,200.00 per year, together with house rent and traveling expenses.
2. That L. D. Sharp be given charge of the HOME MISSIONARY

Work.

3. That he be paid a salary of \$1,200.00, house rent and traveling expenses.
4. That the District Superintendent appoint a CAMP MEETING COMMITTEE of five members.
5. That all buildings, such as Churches, parsonages, or extensive improvements, be approved by the District Superintendent before construction.
6. That the District Superintendent or his assistant make a complete canvass of the District as soon as possible, and assist each pastor in getting a systematic financial program; and as much as possible, arrange that each pastor have a stated amount and a monthly support.
7. That no Church of our District shall call a pastor, evangelist, representative of Foreign Missions, Orphanage, or Rescue Home without consulting our District Superintendent
8. That the pastors instruct their people to send all money intended for General, Foreign and District work through their local and District treasurers to receive credit for same.
9. That money shall be paid from District Treasury as directed by District Superintendent.
10. That all lady workers and preachers' wives wear their dresses to reach from their collar bone to at least half way between the middle of the knee and the floor.
11. That the Rocky Mountain District extend an invitation to the General Assembly to come to Colorado Springs for its next session.
12. That we have the minutes printed as soon as possible and that all the District laws be printed.



### MEMORIALS TO GENERAL ASSEMBLY

1. We recommend the changing of paragraph 72, section 5, of our Manual to read "tithe" in place of "contribute of".
2. We recommend the six months' probation plan of receiving members into our Church.

3. Whereas, There is evident need of a comprehensive financial system for our Church, we recommend the following plan:  
**FIRST, TO CONSIDER THE SOURCES OF INCOME FOR THE LOCAL CHURCHES, BE IT RESOLVED,** That all members of local Churches tithe their incomes regularly into the treasury of the local church, and that the local income be further increased by free will offerings taken for all needs.

**SECOND, TO CONSIDER THE DISTRIBUTION OF OUR CHURCH INCOME, BE IT RESOLVED,** That each local church set its own budget to cover all local expense and in addition set aside a percentage of the local income (except money raised for new church buildings and evangelist's offerings), said percentage, or tithe, to be paid to the district treasurer the first of every month for the purpose of meeting all district and general church claims, the amount of which percentage shall be determined by the District Assembly annually, subject to the approval of the District Assembly

**BE IT ALSO RESOLVED,** That the District act in harmony with the foregoing and plan to raise all district and general claims by setting an annual budget based upon a percentage of local church

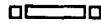
income, disbursing such receipts through the District Treasurer monthly.

BE IT FURTHER RESOLVED, That the General Board of the Pilgrim Holiness Church follow out this same plan and shall set the amount of all general church claims for each district based upon a percentage of the local church incomes as specified above.

4. We recommend that our Manual be changed in section 28, page 22, to read "one out of eight ministers and deaconesses" instead of "one out of five".



### DISTRICT SUPERINTENDENT'S REPORT



To the Ninth Annual Assembly of the Rocky Mountain District of the Pilgrim Holiness Church:

Greetings:

One of the best years in the history of the District has just passed into history. God's great blessing has been ours.

The Lord has helped me to travel 25,000 miles, preaching 156 sermons, resulting in 146 seekers at the altar. I held 50 business meetings, baptized 6 people, dedicated four babies, and raised for all purposes for our Church work \$4,300.00. We organized four Churches—Lagrange, Wyoming; Scotts Bluff, Nebr.; Bladen, Nebr., and Springfield, Colo. Took 47 members into the Church.

A lot has been purchased to build at Lagrange. The new Church in Bladen bought a Church building, paying cash for it. The Church at Kiowa built a nice beautiful Church, and it was my privilege to dedicate it free of debt this June 15th. The new Church at Springfield has a nice large basement put in, all ready to put the top building on.

Besides my labors here in the DISTRICT, the Lord took me down into Mexico where I preached a number of times and hundreds of souls bowed at the altar.

We give GOD all the glory for what He has done.
