Minutes of the Fifteenth Annual Assembly

of the

Rocky Mountain District

of the

Pilgrim Holiness Church

FIRST SITTING

The district assembly was called to order at 8:00 A. M. by Rev. W. L. Surbrook, general superintendent. The members of the assembly joined in singing the hymn, "His Way With Thee." Prayer was led by Rev. C. C. Coleman. The chairman, Rev. W. L. Surbrook, read for a scripture lesson a portion of the twelfth chapter of Romans, commenting thereupon. Following this inspirational message, the chairman spoke briefly of the state of the general church.

It was moved and carried that the first five rows of seats in two south sections and the platform constitute the assembly bar.

It was moved and carried that the hours for gathering be as follows: 8:00 A. M. to 11:30 A. M., 1:00 to 4:30 P. M., and 6:30 to 9:00 P. M.

The following ministers were presented to the assembly and granted seats within the assembly bar: Armor Peisker, George Knight, G. M. Pratt, J. E. Canaday, R. C. Stalcup, Mrs. Pansy Stalcup, Ernest Howell, and Mrs. Sadie Howell.

Upon recommendation of the council, the following were accepted as district licentiates: T. H. Jarvis, A. L. Jones, Roy E. Davis, Mrs. Elizabeth Woods, and D. W. Lacy.

The secretary's request that R. D. Perry be permitted to serve as his assistant during the assembly was granted by common consent.

The motion prevailed that the district superintendent appoint a reception committee. Carl H. Dauel and C. C. Coleman were appointed.

The reception committee presented the following people to the essembly and each was granted an honorary seat in the conference bar: Pev. and Mrs. R. R. Sharp, Rev. E. G. Marsh, Rev. Scott T. Clark, Fev. Kelley, Rev. John Orkney, Rev. Aaron Hulse, Miss Beatrice Van Vranken, Rev. and Mrs. G. C. Avery, Rev. F. E. Glendening, and Rev. Crutz.

The motion was made and carried that Rev. Charles Crutz be given a regular seat in the assembly bar.

Rev. Robert Hahn was presented by the reception committee and was granted an honorary seat in the assembly bar.

The Ways and Means Committee reports were read and accepted.

Partial report of the Resolutions Committee was read and acted upro.

The motion was made to proceed at once with the election of officers. Carried.

Motion prevailed that time be extended to 12:00 in order that this matter might be cared for.

G. C. Avery, J. E. Canaday, A. L. Jones, and John Orkney were appointed by the district superintendent to serve as tellers.

The election of officers resulted as follows: W. A. Elkins, superintendent; W. F. Drown, assistant superintendent; Marion Hill, secretary; Charles Luscombe, treasurer. Additional members elected to the council were as follows: C. C. Coleman, F. L. Freed, and L. L. Miller.

Motion prevailed to combine Educational Committee and Examining Board.

Motion prevailed to place two names on ballot for election of members to combined Educational and Examining Board, the one receiving the highest number of votes to serve as member of the Board for three years, and the one receiving next highest to serve one year. The election resulted in placing Armor Peisker as member of the Board for the long term, and L. L. Miller for the short term.

Motion prevailed that the district superintendent appoint now the Ways and Means Committee for next assembly.

Motion prevailed that the district superintendent be ex-officio member of the Educational-Examining Board.

Motion prevailed to change the time of meeting of the next session to 2:00 o'clock.

Adjourned by the expiration of time.

SECOND SITTING

An opening song service was led by W. F. Drown, various passages of scripture were quoted by members of the assembly, O. J. Spaugh led the assembly in prayer, and the general superintendent gave a brief message on tithing.

Motion prevailed to dispense with the roll call.

Minutes of the previous sitting were read and approved with corrections.

The following memorial to the general assembly was presented and accepted:

BE IT RESOLVED: That as soon as any member of the Pilgrim Holiness Church unites with another denomination, his membership with the Pilgrim Holiness Church will automatically be discontinued.

District treasurer's report was read and accepted.

District superintendent's report was read and accepted.

A rising vote of appreciation was given the district superintendent.

The statistical report was read and accepted.

Roll call of ministers being answered to by subscription pledges to the Pilgrim Holiness Advocate, resulted in 326 subscriptions being pledged.

Motion prevailed to have one hundred fifty copies of the minutes prepared.

Rev. Orvan Keller, of the Kansas District, was presented to the assembly by the reception committee.

Partial report of the resolution committee read and approved.

Adjourned until night sitting with prayer by W. F. Drown.

THIRD SITTING

An opening song service was led by C. C. Coleman, prayer was led by Roy B. Ellis, testimonies were given by A. L. Jones, W. H. Combes, and R. D. Perry, and special music was rendered by Orvan Keller and party. The district superintendent then read a short scripture lesson and made appropriate remarks regarding same.

Various delegates made remarks with regard to the need of pressing into the great soul harvest of this district.

Partial report of the resolution committee read and approved.

Rev. L. L. Miller pastor of the Colorado Springs church read the church covenant to Rev. and Mrs. J. E. Canaday before the assembly, receiving into his church Brother and Sister Canaday who came to us from the Methodist church. This was followed by a season of prayer led by Brother Elkins and Brother Miller.

Orvan Keller and party favored the assembly with another group of Gospel songs.

Minutes of this and the preceding sitting were read and approved.

Several testimonies and requests for prayer were given, after which the assembly was dismissed with prayer by Assistant District Superintendent, W. F. Drown.

STANDING RESOLUTIONS

1. That all buildings, such as churches, parsonages, or extensive improvements be approved by the district superintendent before construction.

2. That no church of our district shall call a pastor, evangelist, representative of foreign missions or other church institutions without consulting our district superintendent.

3. That money shall be paid from district treasury as directed by district superintendent.

4. Being our conviction as to the standard of I Peter 3:3-4, be it resolved that all women of the church shall in public wear their dresses with full length sleeves, close fitting necks, and reaching at least half way between the knee and the floor; also leave off the wearing of all jewelry including wedding rings, and that they dress their children as becometh saints, not with half socks and dresses above the knee.

1. We the members of the fifteenth annual assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our general superintendent, W. L. Surbrook, a rising vote of thanks to express our appreciation of his labors of love and faithful service.

2. We the members of the fifteenth annual assembly of the Rocky Mountain District of the Pilgrim Holiness Church resolve that there be given our district superintendent, W. A. Elkins a rising vote of thanks to show our appreciation of his love and faithful service.

STANDING RECOMMENDATIONS OF WAYS AND MEANS COMMITTEE

1. That all district monies be paid monthly through the local treasury.

2. That the district superintendent be given a salary of \$600.00 per year, together with his house rent and traveling expenses.

3. That all our churches take an offering for our district superintendent on each official visit to each respective church.

4. That pastors and evangelists of this district, when working in the district, pay their tithe into the district treasury.

5. That this assembly proportion each church at the rate of \$2.00 per member, to raise the general and district funds.

6. That each local church furnish their parsonage with at least a cook stove, a heater, a kitchen cabinet, six chairs, a dining room table, and a dresser.

7. Whereas many of our pastors are not receiving sufficient financial support, and whereas many of the friends of the church not being able to give cash, but would like to help in some material way, we therefore recommend that each local church designate one prayer meeting night each month as donation night for the pastor.

8. We recommend that each Sunday school take at least ten cents out of each weekly offering to be sent to district treasurer on district tent fund.

9. We recommend that the annual remuneration of the district secretary and treasurer be \$25.00.

10. With reference to our district support of foreign missions, we hereby recommend that we whole-heartedly support the general board's program of prayer and preaching on missions, and will pledge ourselves to hold weekly prayer service and the monthly missionary rally. We further resolve to set our district missionary budget at \$1,800.00 for the year, one third to go to home missions and two thirds to foreign missions. In connection with this, we recommend that our pastors be responsible for raising their proportionate amount of this missionary offering each month by a free will offering taken at the time of the monthly missionary rally.

WAYS AND MEANS RECOMMENDATIONS ADOPTED BY THIS ASSEMBLY

1. It is recommended that a registration fee of one dollar be charged for all those registering who are 14 years of age and above, at the 1937 camp meeting.
