Minutes of the Second Annual Convention of the Apostolic Holiness Church of Pennsylvania

First business session, Saturday afternoon, March 27th, 1915.

Meeting was called to order by the Superintendent, Rev. G. S. Owen.

After singing we were led in prayer by Rev. H. A. Saneholtz, of Bethlehem, Penna.

It was moved and seconded that we place a copy of the last year's printed minutes in the hands of every delegate present and all those that come, and thus dispense with the usual reading of the minutes. Motion carried.

Next followed the enrollment of the ministers and delegates, which will be found on page of the minutes.

It was moved and seconded that the first six rows of seats at the east side of the church be reserved for the conference bar. Carried.

The Superintendent then greeted the convention by reading the following paper.

To the annual convention of the Apostolic Holiness Church assembled greetings to you in Jesus name:—

As we look over the great State of Pennsylvania, it looks like we have not made much headway the past year and at the same time in looking at our own work we are made to rejoice as we see and realize that God's hand of approval and blessing has been upon us this year in saving and sanctifying of precious souls and in the establishing of Apostolic Holiness churches that we believe will stand as a rebuke to sin and the Devil until the coming of our Lord and Saviour Jesus Christ.

There have been five new churches organized and three new pastors given charges in addition to what we had last year. As we look in to the future we can see better and more prospects of opening new fields than we had at the last convention, and we are not afraid to launch out for God and souls. We expect by the grace of God and the guidance of the Holy Spirit to arrange to keep two tabernacle tents busy this summer and if the Lord so leads that we can get the third one we will keep that one busy also. This convention, the Bethel Herald has a bona fide subscription list of about one

thousand against a list of 500 one year ago. Our board of trustees has purchased grounds for camp meeting and school purposes and our first payment of seven hundred dollars falls due the first of May, we urge all who are interested in this work to help us raise this amount. The second payment falls due in six months time. Our camp meeting doubled itself last year and prospects are that it will do the same again this year and with every increase it means increase of expense both incidental and regular. As we had no thought that the work would grow so fast we made no plans last year to finance our work, hence the burden has fallen on a few and many times the Superintendent has had to go in his pocket to pay many small bills which soon run into dollars, therefore the greatest thing that is facing this assembly is the financial part of our work, which is a very important one. While this work was a small thing the Superintendent could easily look after the management and financial affairs but it has taken on such proportions that we must make arrangements for a part of this work to be done by committees, therefore I advise that we make the following suggestions a matter of serious consideration:

First—That there be a finance committee of three who shall look after the raising of Finance for the State Fund and all pledges shall be placed in their possession and it shall be their duty to look after the collection of the same when due, this committee shall give a report to the State Treasurer at least once in three months and as often as the State Board may deem necessary. Also that one member of the State Board act as chairman of this committee.

Second—That there be a committee of three whose duty shall be to look after the raising of money for the camp meeting indebtedness and they shall work in co-operation with and by the advise of the treasurer of the State Board and Treasurer of the Board of Trustees.

Third—That there be a committee of three who shall look after the financing of The Bethel Institute working in co-operation with the directors of the same.

It shall be the work of this committee to inquire into the financial affairs of the work they are to assist as they will be better able to be of service in aiding the management.

Our work would have made much more headway on these lines than we have but your Superintendent has had more than he could possibly look after successfully. Please give it your serious thought. Your Superintendent has a very promising and growing church to

look after, which is a big work of itself. Again, he has the management and editorial work of the Herald to look after which is a large work of itself and takes considerable time. Then there is the fast growing camp meeting and all the churches and preachers in the State work, which is fast growing into a large organization and to manage all these and look after the financial end and carry so much burden is more than any one man can do. The Superintendent has had very little help along these lines except what the Secretary has given which has surely been appreciated. With this plan and all the committees taking such an interest as though it was their own personal business, we predict a year of success which will far surpass our expectation.

Praying that God will bless each member of this conference and each work represented and longing to see many souls saved and sanctified, I am yours for Bible Holiness.

By motion the chairman was authorized to appoint all committees, said committees to be appointed at the option of the chair.

Chairman then called for a meeting of the examining board to meet immediately at the close of the present session.

By motion we adjourned to meet Monday morning at 9:30.

Second business session, Monday morning, March 29th, 1915, was called to order by the chair.

After the devotional exercises the minutes of the previous session were read and approved.

Committee on Bethel Institute—Carrie A. Yoder, J. Russel Gardner, Mrs Harry Greenwalt.

Committee on Campmeeting Indebtedness—J. L. Sutton, C. C. Rose, J. B. Diehl.

Committee on Resolutions—R. A. Andrews, Harvey H. Leach, Joe Stokes.

This committee will be called upon to report at each session.

Committee on State Fund—Joseph Stokes, Harvey Leach, R. A. Andrews.

Next followed an open discussion on finances. Adjournment for ten minutes.

Meeting called to order by the chair, and after further discussion on the financial part of our work, by motion we adjourned.

The third business session, Tuesday morning March 30th, 1915, opened at 9:30 with Superintendent in the chair.

After singing and prayer the delegates responded to the roll call with a testimony.

The minutes of the previous meeting were read and approved.

Report of the committee on incorporation was as follows: We the committee on incorporation have transacted all necessary business connected with our association and have had our articles of incorporation put on record and have in our possession our State Charter, thus we are an acknowledged corporation by the laws of the State of Pennsylvania.

Moved and seconded that the report be accepted and the committee be discharged with a vote of thanks. Motion carried.

Committee on Campmeeting indebtedness reported that there was \$90 needed by the 21st day of April to meet bills which are now due. It was found that there was \$141.50 in pledges which fell due March 1st, 1915, that remain unpaid.

It was moved and seconded that the committee on campmeeting indebtedness be instructed to prepare a letter to notify all persons who have pledges unpaid and cannot be seen at this time. Motion carried.

Adjournment for ten minutes.

Meeting called to order by the chair.

Further report of the campmeeting committee was then called for.

Moved and seconded that the Board of Trustees pay the Superintendent, Brother Owen, the money he advanced for the transfer of the campmeeting property. Carried.

Committee on resolution reported as follows: Whereas the Apostolic Holiness Church of Pennsylvania, under the blessing of God, has grown to such proportions, that there is an ever increasing expense to care for the work and as there is a deficiency to the State fund and, whereas, we as a church believe and teach tithing as taught by the Word of God. Be it therefore

Resolved, That the pastors and evangelists of this Church be advised to send in to the state fund the tithes of all money received by work on the field to be used in the advancement of this work.

Moved and seconded that the above resolution be adopted and made a part of the minutes. Carried.

On motion the report was accepted as given and ordered paid.

Report of the committee on examining board as follows:

We, the examining board, suggest in as much as many of our licensed workers are not in active work, neither are they able to take the prescribed course of study, the general public is left under the wrong impression regarding their association of the ministry as they are not in active service.

If the applicant should give full proof of his ministry or will express his willingness to enter active service at the first opportunity, license may be granted at the time or later as the examining board deems it necessary.

We suggest therefore that the A. H. C. of Pa., issue exhorters license as the initiative step toward the ministry of the gospel.

Moved and seconded that this suggestion become a motion and made a part of the minutes. Carried.

Second—In as much as two delegates from this state convention are to be present at the next bi-ennial assembly, we suggest that we

instruct them to present the subject of exhorters license to our general body as the initiative step toward the ministry.

Moved and seconded that the above suggestion be accepted. Carried.

Third—That our delegates be instructed to vote for the course of study which our examining board shall give them.

We declare ourselves against our present course of study because it is far beyond the reach of our present ministry.

We do not depreciate the value of education yet we believe that we should follow the example of the founders of our work making the main conditions of licenses and ordination upon personal Christian experience, and a definite call to the ministry and efficiency in soul-winning.

Moved and seconded that we adopt this suggestion. Carried.

By motion we adjourned until four o'clock in the afternoon.

Fourth session was called to order at 4 p. m. by the Superintendent.

After singing and prayer the roll call was made.

Report of the Committee on Resolutions:

Whereas, The Apostolic Holiness Church of Pennsylvania has grown to such extent that it requires the greater part of the State Superintendent's time to look after the work, and whereas our present Superintendent is so encumbered with his local work including the pastorate at Milton, Editorship of the Bethel Herald and other duties, we find that it is impossible for him to give the State work the needed attention, although he is a man of great capabilities, and whereas, he has for the good of the cause, both local and State, requested to be relieved of the responsibility of the State Superintendent; therefore be it

Resolved, That we grant the request of Bro. Owen, and elect one who will have the proper time to look after the interest of our state work in a thorough and systematic way.

By motion the resolution was adopted and made part of the minutes.

Moved and seconded that the convention pay the janitor \$5.00 for his services during the convention, to be paid out of the State fund. Carried.

The registrar of the examining board presented the letter of recommendation of Rev. Harvey H. Leach, from the Ohio A. H. C.,

as being in good standing and wishing to be transferred to Pennsylvania. On motion Brother Leach was unanimously accepted.

A resolution was presented by the women suffrage party that we, the members of this convention assembled, do hereby most heartily indorse equal suffrage as between men and women.

A motion was made and seconded that we adopt this resolution. After considerable discussion the motion was defeated.

Moved and seconded that the officers be elected by the regular order. Carried.

The local campmeeting committee gave the following report:

We, the local campmeeting committee, offer to this convention the following plan which will help to reduce our campmeeting expenses. Let each church which is connected with this State Work, appoint a committee whose work shall be to have their church send a donation of groceries or provisions and this donation to be at the Milton camp grounds at least three days previous to the opening of the campmeeting.

Moved and seconded that the suggestion be accepted and be made a part of the minutes. By motion we adjourned. Carried.

Fifth business session March 31st, 1915, was called to order by the Chair.

After the devotional exercises the minutes of the two previous business meetings were read and approved.

After a most refreshing season of prayer the following officers were elected, Rev. H. P. Adams and C. C. Rose acting as tellers:

Rev. J. L. Sutton, Superintendent; Rev. George S. Owen, Assist-

ant Superintendent; Rev. Carrie A. Yoder, Secretary; Rev. Joseph Stokes, Treasurer.

The following advisory board was elected from five nominees—Rev. H. A. Sanholtz, C. C. Rose and J. R. Gardner.

Rev. Carrie A. Yoder was unanimously elected as a member of the examining board for three years.

On motion adjournment was taken for ten minutes.

Called to order by the Chair. The assembly then proceeded with the election.

It was moved, seconded and carried that we retain the same local campmeeting committee as elected last year with the exception of the vacancy left by Brother McFall's death.

Brothers Chappel, Stokes and Owen were nominated, Brother Owen receiving the election.

The Board of Trustees, consisting of three laymen and two ordained preachers, resulted in the following election: G. S. Owen, John Wagner, C. C. Rose, Joseph Stokes and J. R. Gardner.

The following missionary board was elected out of five nominees.

By motion we adjourned to meet at 4 p. m.

Sixth session called to order by the Chair, March 31, 1915, 4p. m.

Nomination for directors of Bethel Herald was called for, out of seven nominees, the following were elected: G. S. Owen, Carrie A. Yoder, C. C. Rose, H. A. Sanholtz and C. A. Forrey.

Next followed a lengthy discussion on finance of our publication, but no definite plan was laid out.

Brother John Wagner and G. S. Owen were elected as delegates to the biennial assembly.

It was moved and seconded that we have the minutes printed. Carried.

By motion we adjourned.

April 1st, 1915, the Seventh session was called to order by the Chair 9:30 a. m.

After a most lively song and prayer service and roll call was given, the minutes of the two previous sessions were read and approved of on conditions that shall be discussed later.

The committee on the Bethel Institute reported as follows:

In as much as our public schools are engaging in things which we know to be wrong and detrimental to the spiritual life of our chil-

dren, the state superintendent and others felt the time has come when we should put forth an effort to give our children a guarded Christian education.

Therefore the Bethel Institute was instituted last August, where our children can receive an education which will be beneficial to both their spiritual and moral life and will not be influenced by those things which cause children to be disobedient and uncontrollable. The institute at present is under the control of a board of directors appointed by the superintendent and consists of the following persons: G. S. Owen, Russel Gardner, John Wagner, C. S. Gardner, Mrs. G. S. Owen, Miss Nettie Gordon, Miss Carrie Strine, C. C. Rose and Joseph Stokes.

In as much as it has been deemed advisable to place the school under the control of the Apostolic Holiness Church of Pennsylvania, the committee hereby presents the matter to the consideration and adoption of his convention with the following provisions:

First—That the present board of directors as appointed, be made permanent in office.

Second—That vacancy, through death, resignation or expulsion, shall be filled by nomination of the board of direction and vote of the convention.

Third—That no member of the board shall be expelled except through a majority vote of the board and by the convention.

It was moved and seconded that the convention adopt the Bethel Institute as reported by the committee. Carried.

The state missionary board reported as follows:

We, the missionary board met and organized, the following officers wishing the same to be accepted by this convention. C. C. Rose, Chairman; H. A. Saneholtz, Secretary and Treasurer; J. L. Sutton, Advisory Member.

By motion we adjourned to meet at 4 p. m.

The Eighth session opened April 1st, at 4 p. m., 1915, with G. S. Owen in the chair.

This entire session was taken up by the reports of the preachers and delegates, which were greatly enjoyed by all present.

Singing, testifying and praising God were mingled with them.

Each report was accepted as given. On motion we adjourned.

April 2nd, 1915, the Ninth business session opened by singing and prayer.

By motion, Sister M. Galligar was accepted into the conference bar.

After roll call the minutes were read and accepted.

Moved and seconded that we defray all the State Superintendent's expenses to the next bi-ennial assembly. Carried.

The Resolution Committee reported as follows:

First—Resolved, That this assembly extend our heartiest greetings to our new superintendent, Rev. J. L. Sutton and assure him our prayers and our heartiest co-operation in his labors among us.

Second—Resolved, That we bid the school board of the Bethuel Institute God speed in their endeavors to provide a place of learning where the moral and spiritual life of the student is nurtured as well as the intellectual.

Third—Whereas, the people of Milton have so cordially opened their homes to the members of the convention we resolve that we extend to them a vote of thanks and of appreciation for their kindness.

Fourth—Resolved, That the report of this convention be sent to God's Revivalist's Apostolic Messenger and the Bethel Herald.

Moved and seconded— that the above resolutions be accepted. Carried.

By motion the convention reporter is to send in the reports to these papers.

State Missionary Board made the following suggestion, in as much as there is confusion in sending missionary money whereby some mission fields receive more than others; we advise that the money be sent unspecified and leave it with the state missionary board to be sent according to their judgment.

Moved and seconded that we adopt the suggestion. Carried.

By motion we adjourned to meet at 4 p. m.

The final business session which met April 2nd, 1915, at 4 p. m. was spent discussing the financial question confronting us and after the following motion was given we adjourned to meet in one year.

Motion—Whereas, we feel that the bill recently passed in our State Legislature prohibiting the granting of Clerical Railroad Rates in the State, is but a piece of political selfishness and a hindrance to the spread of the Gospel work and in as much as other States are granting such rates and this State has formerly done so. Be it

Resolved. That a committee be appointed by the chairman of the

convention to frame a petition to be presented to the representatives from the counties of the several pastors and evangelists with the endorsement of as many other pastors as can be secured protesting against this law.

Praying the Legislature to pass a law granting clergy rates.

At Monument, the third point on the charge, the people are some of the most receptive to Gospel truth I have ever met. The Ambassadors of Christ also, have always the same abundant entrance unto them. And for their "work of faith and labor of love, and patience of hope, God is rewarding them by adding some precious souls to the Church of the First-born. Holiness has come to Monument to stay. Praise Jesus.

So we still have six members there at present in good standing.

REPORT FROM McKEESPORT
