



# Approved Ministers

"In all things approving ourselves as the ministers of God." 2 Cor. 6:4.

There is no greater calling in all the world than a call to the ministry, and since this is true there is nothing more important in all one's ministerial career than that his life's calling should be a success. No one in the world can make it a success but the minister himself. If you are called of God to preach, the Holy Spirit will endue you with His gifts for your calling. The man who does not have the Holy Spirit's gifts to preach and the gifts of the Spirit for the ministry has no business in the ministry. If you are really called to preach, you will seek to devote your entire life to your life's calling. "Are you called to preach?" Joseph Parker asks. "If you can keep a clear conscience and do anything else, you are not called," he declares.

Let me divide my subject under three heads: First, your life; second, loyalty; third, leadership.

With reference to your life, let me speak first concerning your prayer life. There is nothing more important in all of one's ministerial career than this one phase of his life. There are many things in life you can neglect and get along without, but you neglect your prayer life, at the peril of your own soul, together with the peril of scores of others. When you pray do you really pray, or just say words? Is your soul really unctonized and blessed in prayer, and do you touch God when you pray, and do the touches of God come upon your soul, or do you more or less simply talk to empty space? Does your prayer life leave you fresh, blessed, buoyant and bubbling, or has it become more or less mechanical and professional? Are you really a man of prayer? If not, why not? Take the churches that were at one time orthodox, whose laymen were blessed under the bubbling ministry of Spirit-filled men. When those churches started apostatizing they did not start in the pew; they started downward in the pulpit; the pulpit quit praying, quit getting blessed, ceased to get anointed, and the minister died out in his own spirit life. Then doubts crept in and his spiritual loss, together with heterodox reading and the contacts of

other unspiritual men, led him astray until today he is wrecked on the rocks of modernism, which is nothing more or less than cultured atheism.

Oh, how many have failed here! Having failed to pray and keep blessed and anointed they have lost the sweetness from their souls and have become harsh, critical, driving, censorious, sarcastic, full of irony, ambitious, office-seekers, and political wire-pullers. If you have grace enough to take you up at the Rapture, you will neither be a political wire-puller, nor seek office, nor have anything to do with the crowd that deals in that kind of business. The Holiness Movement, through all the years of its existence, has frowned on that business as carnality. If it were carnality fifty years ago, it is carnality today.

There are no substitutions for prayer. There is nothing that will more quickly fit a man for the ministry than humble, unctuous prayer that brings his soul into fellowship with God, and yet there is nothing that will more quickly unfit him than a failure along this line. A good friend of mine in the ministry declares, "Either your praying will stop your sinning, or your sinning will stop your praying."

Second: Let us briefly mention your study life. Everyone who is called to preach is called to study. The man who will not study has no business in the pulpit. The admonition of the Holy Spirit, through the Apostle Paul, is to "Study to shew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." Over and over the Apostle Paul admonishes his leaders to give attention to reading, to be studious. Study will keep you fresh, informed, and in demand, but a lack of it will leave you dry, and few will care for your hash.

Third: Your ministerial life. The Apostle impassionately admonishes to "make full proof of your ministry." May I ask you, Are you really ministering to the spiritual needs of your people, or are you just a preacher? Almost anyone can preach, without grace; but no one can minister to the spiritual needs of his people who is not himself Spirit-filled. No spiritual minister is satisfied to preach to a lot of empty pews month in and month out and do nothing about it. If he is Spirit-filled and carries a burden for souls, he will go out after people and bring them in, or he will be ready to leave that pastorate and go where he can do something for God.

### **Loyalty**

In speaking of loyalty, we have in mind your allegiance or faithful devotion to God and the church you serve. Is your loyalty to your church such that you could say with Paul, "Follow me as I follow Christ"? If every member in the church had your type and standard of loyalty, what kind of church would it be? The reason some churches are not loyal is that the pastor is not. Would you consider a pastor a loyal Pilgrim who looks only after his local needs and his personal support and does practically nothing for district and general interests? Isn't it a fact that genuine loyalty ties us so closely together that we either sink or swim together? Have you ever noticed how much you appreciate the loyalty of those under you, and how much you have to say if someone appears disloyal? What do you suppose your leaders are thinking when you show a lack of loyalty? Is your loyalty such that it attaches your congregation and followers to God and the church, or just to yourself? Have you built up a type of loyalty that your church could move you and the work would still go on, or have you so built the work around yourself and made it appear that you are so indispensable that if they were to move you it would be like pulling up a tree from the lawn—it would take all the sod with it?

### **Leadership**


Every Spirit-filled minister, whether conscious of it or not, is a leader among his people, and he is leading his people either Godward

and heavenward, or hellward. He is leading his people into deeper piety, reverential fellowship and love for God and loyalty to his church, or to the very opposite.

May I ask, Is your leadership such that your people are becoming more spiritual month after month, or has it led them to the place where they have become a gossiping, fickle, laughing, visiting, prayerless group of people? Oh, the lack of reverence today in the church of God! Is your leadership such that it causes your people to place their tithe with confidence in the local church, or do they send it all over the country to independent institutions where the property, worth perhaps scores of thousands of dollars, is in one family or in the leader's name? May I ask you again, Is your leadership such that it leads you to see that the church property where you are pastor is deeded properly to the Pilgrim Holiness Church, or is it just held locally? If it is held locally and is not deeded to the Pilgrim Holiness Church, can you conscientiously tell people they are paying on Pilgrim Holiness Church property when the facts are that they are paying for an independent institution? What do you consider constitutes a fraud in religion? Isn't it a fact we must be conscientious along these lines, as well as all others?

Finally, may I ask, Is your leadership such that the Pilgrim Holiness Advocate is the best paper in all the world for our Pilgrims to take, that there is no other paper that can fill its place, and do you see to it that your members and constituency, as far as possible, are taking the paper? May I quote to you a statement from a Methodist bishop concerning their church paper. He said, "It ought to be understood that a Methodist Episcopal minister who does not push the circulation of our paper has gone mentally and spiritually astray," and that "a Methodist Church member whose home is not supplied with it is in disgrace." I wonder how that would sound if we were to put our name in there and quote the Methodist bishop as saying, "It ought to be understood that a Pilgrim minister who does not push the circulation of our paper has gone mentally and spiritually astray, and that a Pilgrim Church member whose home is not supplied with it is in disgrace." That may be too strong for us, but it wasn't too strong for the Methodists. It should be an established fact in our thinking that to fail to push our church paper indicates a trend away from our ideals and standards. It means decreasing loyalty, decreasing intelligence of our work, decreasing sympathy toward our church and all of its activities.

## “Occupy till I Come”

“Occupy till I come.” This is Christ’s message to His servants in this extreme hour. When Jesus gave the parable in the nineteenth chapter of Luke, from which these words are taken, He spoke for our day.

His divine injunction holds not only the bright promise of His coming, but the entire parable is a revelation of the nature of our occupancy. It tells us plainly what we are doing when we occupy till He comes. The nobleman put certain sums of money (pounds) into the hands of his servants. These servants were to use and protect these funds for their Master. They were to guard and advance His interests. This is what we are to do. This work is not our enterprise, neither is it just the matter of the progress of a church denomination. It is the joyous responsibility of protecting the interests of Jesus Christ.

This New Testament concept of things lifts the whole effort for God entirely out of the ordinary run of things. It places the whole foreign missionary enterprise upon the high plane of His eternal purpose. It was Peter, in the fifteenth chapter of Acts, speaking of early missionary triumphs, who so clearly discerned this divine program. “God,” he declared, “at the first did visit the Gentiles to take out of them a people for His name.”

So it is not just a matter of converting so many black men or yellow men, or baptizing them, instructing them in Christian doctrines, and forming Christian churches out of them. No, a thousand times no! God, by His Spirit, through the Word preached by faithful Spirit-filled missionaries, is taking out of the Gentiles a people for His name. These same precious people, who have been denied much of opportunity here, will join in the eternal fellowship of the redeemed of all ages. How heartening such truth should be for all of us who labor for the Lord, whether in the homeland or abroad!

The foreign missionary work of the Pilgrim Holiness Church is to be found in many lands: Mexico, the British West Indies, the Virgin Islands, Netherlands West Indies, British Guiana in South America, Cape Colony, Swaziland, Natal, the Transvaal, and Northern Rhodasia in South Africa, the Philippines, and China. In these mission areas almost every kind of Christian work is now in progress. Evangelism, missionary churches and preaching stations, Bible schools and mission Sunday schools, visitation, colportage work, medical work, building, etc. It is all there and in progress all the time; and it is all for one great purpose, “To take out a people for His name.”

And how long shall such work continue? These are days of great stress, days of pressure, and days of uncertainty. How long? His word is the only message for the church of our day, "Occupy till I come." We are not to occupy until we get tired or until the funds run low. We are to occupy till He comes. It has meant a great deal to occupy; it will mean more in the tomorrows if the Lord tarries. But, regardless of what it involves, we are to occupy until He comes.

All of which brings us to the great and solemn truth that the foreign missionary task is unfinished. There are workers still in training; infant Christian churches that call for careful, prayerful guidance in the things of God still are our responsibility; vital missionary projects that are only partly completed and call for action; then, there are those vast unevangelized fields that still await the Gospel. Yes, the task is unfinished and will be until He comes.

No time for trifling in this life of mine,  
Not this the path the blessed Master trod;  
But strenuous toil; each hour and power employed  
Always and all for God.

Time swiftly flies; eternity is near,  
And soon my dust may lie beneath the sod;  
How dare I waste my life or cease to be  
Always and all for God?

I see the heathen perishing around

# “Our Share of the World”

“Shall we, as a church, evangelize our share of the world? This is the ringing challenge flung down to American Christianity today. America, stretching between the two great seas, in whose heart flows the rich blood of many nations; into whose mountain safes God the Almighty has planted the magic genius has riches of fabulous amount; in whose plains that blossoms into harvests with which to feed the hungry multitudes of earth; nursed by Puritan and Pilgrim; defended by patriot and missionary; guided by the pillar of cloud by day and of fire by night; sanctified by a faith as pure as looks up to heaven from land. O America! Let thy Master make thee a savior of the nations; let thy God flood thee with a restless passion for conquest; let thy Father lead thee over mountain and plain, through fire and flood, through sickness and pain; out to the great hour when all men shall hear the call of Jesus, the last lonely soul shall see the uplifted cross, and those that will be bound back to the heart of God.”

The above is a quotation, but if we have the right spiritual equipment, our force will be as living waters in a thirsty land. To many people home missions means little box churches, log meeting houses in the mountains, Sunday schools in one-room school houses, itinerant evangelists in forlorn and needy communities, and missions set amidst the babble of the slums of great cities. In other words, to many people home missions is only a sort of rescue mission enterprise operating on the fringe of things.

It is true that home missions has done, and to a good degree, is continuing to do just the very things we have mentioned, but this work alone fails utterly to present a true picture of the scope and significance of the home missionary enterprise throughout the country.

It has been well said, “Inevitably we think of home missions as more of a passion than of a movement or program.” In reality it is the spirit of a sanctified life. Whatever else it may be, home missions is essentially and fundamentally an undertaking of faith and vision in building to save souls, regardless of position.

The field of home missions is more than a geographic concept to be bound and measured. It is more than an engineering feat or an exercise in the mathematics of a population census. It is great in area, but to count the miles between its outposts is only to hint at its spiritual vastness. The field and formal activities may be cataloged, but the end is the salvation of the lost and a constructive building up of the body of Christ in this world. It is the crystallization of the passion to win souls for Christ. In seeking this end, it has laid hold on various methods—propaganda, direct evangelism, legislative enactment, prayer, and means. The methods to be pursued, however, important they are, must not be emphasized more than the results. If we lose our identity as cause in the great program of the church, the result will be tragedy. To lose the vision of a lost world is to lose our power of identity with God and with the church. In this urgent task of evangelizing America, we welcome the support, co-operation, prayer, and means of all special agencies within the church which are seeking the

same ends even through more extensive methods and even to hitherto unreached areas.

American life is undergoing very fundamental changes these days, of which fact no one is more aware than are home mission leaders. Yet, in the midst of it all we discern the spiritual perspective and observe that the United States and Canada are yet far from being vitally Christian. Our task is far from being completed, and as long as this is true there will be a vital home missionary task to be performed. We trust that home missions remains a distinctive enterprise. As the darkness of the last days settles down upon the earth, the church should more and more center its attention and ministry on the souls of men. Evangelism is the heart of home missions; the realm of God on earth its goal.

Today, home missions should be attacking on many fronts, bringing a new efficiency to the local church, restoring evangelism to its place of primary concern to make its contribution to the racial problem and to help lift the economically depressed to positions of opportunity; but above all we should instill the spirit of soul burden and spiritual vitalization as an instrument for the advancement of the kingdom of God on earth. Here again we say, home missions is more than a movement or a program. It is the activity and culmination of a burning passion, the winning of lost souls in the homeland.

In this age of rush and hurry we wonder if God's people are taking time to read. Paul, the Apostle, says, "Give attendance to reading," also, "Study to show thyself approved unto God, a workman that needeth not to be ashamed." Though Paul was an educated man, he considered it necessary to read and study. Even when in prison, Paul asked Timothy to bring him his books and parchments. This inspired man of God had been preaching at least 30 years, yet he wanted his books. He was a man of wider experience than most men, had written the major part of the New Testament, had seen the Lord and had been caught up to the third heaven, there hearing things unlawful for man to utter; yet he wanted books.

The Pilgrim Publishing House exists for the great purpose of supplying the Christian public with good reading—with Bibles and all kinds of Christian literature. It is the property of the Pilgrim Holiness Church, which makes each member of the church a partnership owner, and each and every member should look upon it as "my," or "our" publishing house. It has been made possible and is being maintained by our ministers, our churches and their members, and their Sunday schools who buy from their own publishing house. We hope there is not a single member in the Pilgrim Holiness Church but who feels he has a share in this work because he is loyal in purchasing from it.

Though your manager continually seeks the help of the Lord in making this department an asset, he cannot be the success he should be without the loyalty and co-operation of our church constituency. A few offerings are sent in for the publishing interests, and though we are glad to get them, yet we do not appeal for gifts or donations in this department. All we ask is the opportunity to supply your personal, church, and Sunday school needs. We consider the profit on the article or articles you purchase as your contribution to this department.

If the Lord continues to bless its growth, we shall need a larger headquarters, and our church will probably want to put in its own printing plant some day. Would it not be wonderful if, when that time comes, we could have enough in reserve from the publishing house profits that we should not have to ask the church for anything! This is not impossible. Let us create a slogan: "Buy From Your Own Publishing House!"

Under the department of Pilgrim Publishing House we have three sub-departments: (1) Sunday school supplies, (2) Advocate, (3) Bibles, books, etc.

1. The Lord has been making our Sunday school literature a blessing and our schools have heartily accepted it. Its usefulness is reaching beyond our own denominational borders, as people are calling for something more pronounced on Holiness and other important doctrines. We have been advertising our literature outside of our own church, and we are receiving calls for samples from people who tell us they

are going to try to get their churches to use it, as they need our kind of literature. We are glad to tell you we have doubled our Sunday school sales in the last five years. We rejoice to note the growth of a number of our schools as we see their orders increasing; also, new schools are opening. I pray God will continue to give us even a greater Sunday school vision that more people will get the Gospel truth. If you desire any kind of Sunday school material, feel free to write us, and we shall be glad to give your request our personal attention. If we should not have what you want, we will get it, if possible, as we have close contact with other denominational houses who give us a fair commission on what we sell of their items.

2. The Advocate, we believe, is second to none. The subscription price is only \$1.00 per year (52 issues), a price below cost, thus accumulating in a year's time several hundred dollars deficit; but we depend on our faithful and loyal Pilgrims and Christian friends to purchase from us profitable publications to meet this deficit, as well as to help defray other expenses necessary to the carrying on of the publication department. We constantly desire a greater number of subscriptions that the messages and help this silent messenger contains may be a blessing to all who receive it. ## FIRST SITTING

A motion was passed that the District Superintendent make the appointments to fill the vacancies on the various committees.

The District Superintendent's report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

The Ways and Means Committee gave a partial report. (Printed in Reports of Officers, Boards, and Committees.)

The statistical report was read by the District Statistician, Rev. Mark Storey.

A motion prevailed that the roll call be dispensed with for the remainder of the Assembly.

The minutes of the last sitting were read and accepted.

The Assistant Superintendent's report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

The Home Missionary report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

We were favored with a song by Rev. Joseph T. Thomas.

A motion prevailed that the five new churches be received into the Conference. They are: Rodney, Ohio Ridge, Boonville, Harvey Flats, and New Albany.

A motion prevailed that Mrs. Thomas Lauderbaugh be seated within the Conference bar as a delegate for Boonville.

The report of the Auditing Committee was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

The report of the Camp Meeting Treasurer was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

Rev. Crider, pastor of the Milton Delaware Pilgrim Holiness Church, was introduced to the Assembly. A motion prevailed that Rev. Crider be granted an honorary seat within the Conferenc bar.

The District Superintendent introduced the evangelists to the Assembly.

The Ways and Means Committee gave a partial report. (Printed in Reports of Officers, Boards, and Committees.)

The District Treasurer's report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

Rev. Angus Jeffers invited the Ministerial Convention to the Terre Haute Hulman Street Church next year. Other invitations were received from Muncie, Evansville Second, Indianapolis First, Elwood, and West Terre Haute. A motion prevailed that the invitation from the Terre Haute Hulman Street Church be accepted.

A motion prevailed that the District Council set the date for the Ministerial Convention.

A motion prevailed that the General Superintendent be invited to be the main speaker at the Ministerial Convention.

A motion prevailed that the time be extended five minutes.

A motion with amendment prevailed that the whole morning sessions of the next Ministerial Convention be for the preachers, their wives, and workers only, and that the General Superintendent and District Superintendent arrange the programs for the above-mentioned sessions.

A motion prevailed to adjourn. Rev. F. B. Dunn dismissed the session with prayer.

## FOURTH SITTING

The fourth session was opened with the devotions in charge of Rev. Walter Speck. Rev. Crider read the thirteenth chapter of St. John and led in prayer.

The minutes of the last sitting were read and accepted.

A motion prevailed that the District Superintendent appoint a committee of three to take care of the remainder of the program of the Ministerial Convention that has not yet been taken care of.

A motion prevailed that the election of officers take place at 3:00 p. m.

The Ways and Means Committee gave a partial report. (Printed in Reports of Officers, Boards, and Committees.)

Rev. and Mrs. Morgan from the Idaho-Washington District, Rev. and Mrs. Bryan from the Ohio District, and Rev. and Mrs. William L. Dunn coming to us from another denomination, were introduced to the Assembly.

The order of the day was the election of officers.

A motion prevailed the District Superintendent appoint six tellers.

Rev. Frank Youngman, of Columbus, Ind., coming to us from another denomination, was introduced to the Assembly.

The District Superintendent appointed Rev. Moreland Yundt, Rev. G. R. Bateman, Rev. James Pursley, Rev. Ralph Nibarger, Rev. E. W. Hall, and Rev. Walter Speck as tellers.

A motion prevailed that the order of the day be postponed long enough to receive into the Conference ministers coming to us from other districts and churches.

The Examining Board's report was read and accepted.

After a few moments of silent prayer for the Lord's guidance in the election of officers, Rev. W. L. Surbrook led in prayer.

Ballots were cast for District Superintendent, and Rev. Area Montgomery was re-elected on the first ballot. Rev. George Huff was re-elected Assistant District Superintendent, and Rev. Floyd Dunn was re-elected District Secretary. Rev. E. V. Halt was re-elected District Treasurer.

A motion prevailed that the present District Statistician be re-elected by acclamation.

The District Council reported its nominations for members to serve on the Educational Board.

A motion prevailed to extend the time until the vote be taken and the results be announced at the next sitting.

The Assembly adjourned by expiration of time. Rev. P. W. Thomas dismissed with prayer.

## DISTRICT SUPERINTENDENT'S REPORT



Rev. Area Montgomery  
District Superintendent

To the Thirty-seventh Annual Assembly of the Indiana District of the Pilgrim Holiness Church, convening at Frankfort, Indiana, September 3, 1940, I beg to submit the following report.

This has no doubt been a very strenuous year for all of us. The fast decline of standards of morality and decency, the awful scourge of war, and the uncertainty that is all about us make demands on each of us that require action, prayer, determination, and faith. The question faces us whether we will be able to stem the tide or will give way to this flood of worldliness that is sweeping this way. Do we stand four-square against immodest dress and immorality? To yield means to lose our place and to go down with this light frivolous age. Let us get a firmer hold on God and refuse to be drawn away by the world. Jesus said of the disciples, "They are not of the world, even as I am not of the world." I still believe that one truly saved is through with the world and its pride, clamor, and nudity.

This has been another busy year. There is no depression in the work of the Lord. For many preachers today there are not enough hours in the day or enough days in the week to enable them to finish their work.

Our revival efforts have been many throughout our churches. Numbers have been saved and sanctified. Let us not let the revival fires go out. Let us not have any ease in Zion.

**Churches Organized**—We have organized five churches in our District this year. They are Rodney, Ohio Ridge, Boonville, Harvey Flats, and New Albany. One church building has been deeded to us with one-half acre of ground. It is located near Short's Corner in the southern part of the state. It has not yet been organized. Rev. Irene Steger and her people were instrumental in constructing a nice stone church at Rodney.

**Parsonages**—We have contracted for six parsonages. They are at Hope, Columbus, Medora, Vincennes, New Castle, and Scott City. We are glad for this and pray that every church will soon own its own parsonage.

**Local Improvements**—Numerous improvements have been made on the churches, such as putting in full basements, painting, and redecorating. The former Beulah Mission purchased a splendid building and is now known as the Sixth Avenue Pilgrim Holiness Church.

**Old People's Home**—God has taken care of our home. Thanks to our churches as they stand by in the fear of the Lord. If Jesus tarries we will some day be old and may need someone to take care of us.

**Old People's Home Farm**—We have added 30 acres to our farm, making a total of 120 acres. God has been helping us and we are expecting our farm to be quite an asset to us in operating our school and home.

**Camp Grounds**—A new dormitory of twelve rooms has been erected this year. We drove a new six-inch well 89 feet nine inches deep and installed a new pump, the output of which is 1800 gallons of water an hour.

We have five preaching points and 117 organized churches in our District. We have visited each one of them twice or more, with the exception of Coalmont, Monon, Alexandria, and Windfall.

I have made 282 visits to the churches, preached 275 times, attended eight Zone meetings, four Council and School Board meetings, and one General Board meeting. I have preached two funerals, organized three churches, and dedicated one. I have traveled 33,000 miles and received my salary in full and \$359.00 for my total traveling expenses.

### NOTICE

All ministers who have not been ordained shall appear first each year before the Educational Board, bringing recommendations from local church, whether notified or not, at each annual Assembly.

The Examining Board is the second board before whom all licensed ministers must appear, and not the first.

All ministers appearing before the Educational Board shall bring their recommendations with them.

Students are not to receive or use any helps when passing examinations.

### REPORT OF THE WAYS AND MEANS COMMITTEE FOR 1940

1

We recommend that the office of Superintendent of Old People's Home and farms be under the administration of the District Council.

2

We recommend each pastor take a two weeks vacation with salary.

3

We recommend that all those desiring to pay for their board by serving as a worker during the Camp Meeting be required to pay a registration fee of \$1.00 when accepted as a worker by the Camp Meeting Committee.

4

We recommend that each preacher fill out two copies of each quarterly report and send one copy to the District Superintendent and one to the District Statistician.

5

We recommend that the matter of whether young people's zone rallies be held jointly with or separately from the church zone rallies be left to the discretion of each zone, and that this matter be decided at a joint group meeting of the zone.

6

We recommend that the 1941 District Young People's Rally be held at the opening of the Camp Meeting, the time of opening to be set by the Young People's Committee.

7

We recommend that the District Budget be pro-rated as follows: District funds, 60%; General Assembly, 5%; Old People's Home, 8%; Frankfort Bible School, 5%; District indebtedness, 10%; Burial Association, 2%.

8

We recommend that each preacher taking the study course be furnished with an individual recommendation blank from the local Church Board, the same to be carried by him to the Educational and Examining Boards.

9

We recommend that this Assembly go on record favoring the use of the name "Conference" for our District and general legislative meetings.

10

We recommend that each Young People's Society be requested to send an offering for the Young People's Rally to the District Young People's Treasurer; also that churches without organized societies be invited to send an offering for the same.

11

We recommend that the District Statistician be authorized to purchase needed new book and printed pages to conform to the general report blanks, the same to be paid for by the District Treasurer.

12

We recommend that the standard mileage rate set by the District Council apply to District officials and those called for committee work. All those called for work on the camp ground are to be paid their traveling expense.

13

We recommend that each church of the District send in an offering of at least \$3.00 for the expense and entertainment of the pastors during camp.

14

We recommend that in case the Assembly considers changing or increasing the amounts in financial recommendations by the Ways and Means Committee that the Ways and Means Committee may appeal to the Assembly for a committee to investigate the financial balance of the treasury before voting on the change, this investigating committee to consist of one member from the District Council, one member from Ways and Means Committee, and one member chosen from the Assembly.

15

We recommend that the District Statistician be empowered to return reports which are inaccurate for correction, corrected reports to be returned within ten days. We further recommend that mailing expense be met by the District.

16

We recommend that the following recommendations be dropped: Numbers 3, 4, 10, 25, 28, 29, 38, 44, 49.

17

We recommend that each church help support the Frankfort Bible School by sending to the District Treasurer each month an amount equal to 1% of the gross receipts of the local church treasury for the current month.

18

We recommend that in order to finance the work of the District Young People's organization during the year each society send in an amount equal to two cents per member each month. This amount to be sent regularly to the Young People's District Treasurer.

19

We recommend that immediately following the District Assembly the Secretary mail to each pastor an itemized postal notice of the financial requirements of the church for the year.

20

Inasmuch as the premature closing of the Camp Meeting left a financial obligation, we recommend that each church send an offering for same as soon as possible to the Camp Meeting Treasurer.

21

We recommend that each church raise three cents per member each

month for District Home Missionary work and church extension, money to be paid to the District Treasurer.

22

Inasmuch as it is sometimes impossible for the local church to send district funds to the District Treasurer by July 31, we recommend that the District Treasurer hold his books open until August 10.

23

We recommend that all money raised by representatives of General Home and Foreign Missionary interests be applied according to the Manual as provided in paragraph number 12, section 127.

24

We recommend that the Ways and Means Committee meet at the call of the chairman prior to the next District Assembly. Their expenses and entertainment to be paid by the District Treasurer.

25

We recommend that 1,000 copies of the Assembly Minutes be published within thirty days after the Assembly adjourns, and that all orders for same be sent directly to the District Secretary.

26

We recommend that the ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children, and also ordained ministers and their wives of other churches be given meals during Camp Meeting.

27

We recommend that all pastors, evangelists and unstationed ministers failing to send in their reports to the District Statistician by the tenth of the month following the end of the conference year be denied a seat within the conference bar for that year.

28

We recommend that the District Budget consist of 10% of all money raised by the local church, Sunday School and Young People's Societies, except that raised for missions, general budget, building funds, and all funds raised for specified District interests. Building fund purposes shall be interpreted to include rent on parsonages and churches and money paid on contracts of the same.

29

Inasmuch as the zone meetings have been beneficial in advancing the spiritual, educational and doctrinal interest of the District, we recommend they be continued. We further recommend that the conference ministers of each respective zone meet as soon as possible and elect their President. This election shall be subject to the approval of the District Superintendent.

30

We recommend that each church provide a parsonage with telephone.

31

We recommend that the annual business of the local church be closed on July 31 of each year, but that pastors shall continue in service until and including the Sunday after the District Assembly, the local church to report the extra time in the next year.

32

We recommend that the regular Assembly stenographer be paid \$15 and her entertainment during the Assembly.

33

We recommend that our District Superintendent be paid a salary of \$2,100.00 and expenses.

34

We recommend that all persons taking the preacher's study course shall have their examinations in the hands of their instructors by July 16 of each conference year.

We recommend that at each annual Camp Meeting, on the last Thursday, Friday and Saturday, there shall be one daily session of the Educational and Examining Boards for the purpose of the examination of ministers. All ministers knowing themselves due to appear before these boards are urged to be present.

We further recommend that the time of such sessions shall be announced from the platform.

35

We recommend that needed repair be made to our Tabernacle and buildings, and that no new buildings or changes be made upon our State Camp Grounds unless authorized by this Assembly or two-thirds majority vote of the District Council and the Camp Meeting Board.

36

We recommend that the District Secretary be paid \$50.00 for his services for the year of 1940-1941.

37

We recommend that the District Statistician be paid \$30.00 for his services.

38

We recommend that those pursuing the study courses send for their home study questions early in the year, forwarding a large stamped envelope with each request to cover cost of mailing questions, etc.

39

We recommend that only ministers, their wives and unmarried dependent children and lay delegates be given entertainment during Assembly. All entitled to this entertainment shall be duly registered and given cards of recognition. For all other entertainment the same rate shall prevail as during Camp Meeting.

40

We recommend that no delegate to the District Assembly be given free entertainment during Camp Meeting.

41

We recommend that there be a Publishing Committee composed of the District Secretary and two appointee members. It shall be the duty of this committee to publish the Assembly Minutes.

42

We recommend that where parsonages are not equipped with heating device that provisions be made for same by local church.

43

We recommend that each church raise the equivalent of four cents for each of its members per month for the Old People's Home and send this money to the District Treasurer the first of each month.

44

We recommend that our District Camp Meeting begin on the second Friday of August each year.

45

Whereas, each year there is a difficulty in securing a correct ministerial list, we recommend that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of his church, respectively, with correct addresses.

46

We recommend that we have two Examining Boards of three members each. Each board is to work independently of the other; the work

of these boards to be equally divided. Matters necessitating counsel may be brought before a joint session of the boards.

47

Whereas, this has been the second year that recommendation No. 10 in the 1939 Minutes has been in our Minutes, and whereas for that reason leniency and mercy has been extended to those who failed to meet its demands; therefore, be it resolved that this rule be rigidly enforced in the 1941 Assembly.

Be it Further Resolved, that our Statistician presents the names of those who fail to meet the requirements of said recommendation to the District Secretary, who shall read the names.

48

We recommend that where churches are located in cities, that the location of the church appear in our Minutes.

49

We recommend that no pastor call an evangelist outside of our church without the approval of the District Superintendent.

50

We recommend that the deacons or deaconess arrange for a monthly donation for pastor, such donation to be announced publicly.

51

We recommend that the heads of departments of the Camp Meeting Board and Stand Manager be authorized to make purchases for their respective departments. We further recommend that all bills for said purchases be placed in the Camp Meeting Treasurer's hands before the close of the Camp Meeting.

52

We recommend that the Nominating Committee present seven names to this Assembly, from which five shall be elected as Board of Directors for Frankfort Bible School.

53

We recommend that no pastor or local church board shall sell any real estate belonging to local church without the consent of the District Superintendent.

54

We recommend that we have one Assistant Superintendent who shall be paid \$4.00 per day, or fraction of a day, while he is actively engaged in service to the District, plus the traveling expenses incurred in such service.

55

We recommend that the District Treasurer be paid \$110.00 for his services.

56

We recommend that the District Council be given the privilege of forming small churches into circuits.

57

We recommend that each church give to the Old People's Home a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the church.

58

We recommend that the District furnish the Educational Board such copies of sets of questions as may be needed this year.

59

Inasmuch as Sunday school work is greatly neglected in many places, we recommend that each zone have a Sunday School Convention every six months. We further recommend that a Sunday school leader be appointed for each zone by the District Superintendent and respective zone presidents.

2

Whereas, this being the tenth consecutive year our General Superintendent has so efficiently presided over our Assembly; therefore, be it resolved that we show our appreciation by a rising vote of thanks and extend him a hearty invitation to preside at our 1941 Assembly if Jesus tarries.

3

Whereas, our District Superintendent has faithfully and untiringly served the District another year; therefore, be it resolved we show our love and appreciation by standing and saying a hearty, "God Bless you."

4

Whereas, God has called away from our ranks Miss Martha Noggle, one of our ordained deaconesses; Rev. Clyde Shearer from our neighboring District of Ohio, a former Indiana Superintendent, and Brother Jacob Shoemaker, one of the members of the Shoemaker Memorial Home, and the whole Camp was saddened by the unusual death of the infant son of Rev. and Mrs. W. L. Daugherty; be it resolved that we express our sympathy by standing for a moment of silent prayer followed by prayer by our District Superintendent.

5

Whereas, God has graciously blessed us as a District by the re-opening of our School at Frankfort and having completed the year without debt; be it resolved that we pledge our loyalty and prayers and urge our young people to attend.

6


