REPORT OF THE DISTRICT SUPERINTENDENT

To the 26th Annual Assembly of the Kentucky District of the Pilgrim Holiness Church:

Greetings to you in the precious name of Jesus!

The curtain of another Conference Year has fallen. While we have not escaped without battles, yet the past year has been the busiest and the best year of my ministry.

Months prior to our last District Assembly we were deeply impressed that Quarterly Group Meetings would be a stimulant to our district. We took the matter up with our council and they kindly consented to have them. The district was then zoned into five separate groups, and group meetings were held quarterly, which proved to be great blessing to our entire district.

We have organized six new churches, at the following places: Louisville, Ashland, Central City, Tram, Glancy Fork and Stinson. We have some missions, which are not organized. The churches at Prestonsburg, Erlanger, Maysville, and Fourth Church at Ashland have been painted; the Garvin Hill Church has been underpinned. We have a deal on now at Louisville to buy a church and parsonage. We have bought a tent, size 30 x 50, and about 35 beds for camp; and have raised \$110.00 for dormitory.

I have traveled 16,535 miles; held 3 revivals; preached 161 times; conducted 88 business meetings and 16 group meetings; had 318 seekers at the altar, and many happy finders; received \$300 for travelling expenses and my salary in full.

We have pushed revivals, home and foreign missions, the budget, the Sunday Schools, the "Advocate," spirituality and Bible standards. The Lord has helped us in each department. To Him be all the glory!

Brother J. D. Riffe died February 6, 1935. He was a charter member of the Pilgrim Holiness Church at Rush, Ky., and was a faithful member.

Sister Emma Charolette Glass died November, 1934. She was a charter member of the Pilgrim Holiness Church of Rockdale, Ky., and was loved by all.

Sister Lizzie Partlow died June 9, 1935. She was a member of the Pilgrim Holiness Church of Willard, Ky., was a faithful member for twenty-four years.

Sister Katie Weedman, died January 29, 1935. She was a charter member of Cloverport Pilgrim Holiness Church, and a faithful Christian.

Sister Sarah Willis, who died since last Assembly, was an ordained minister in the Pilgrim Holiness Church, and a wonderful Christian and worker.

GENERAL PROCEEDINGS

First Session of Kentucky District Assembly at Aspen Grove, Ky.

August 5, 1935

The Twenty-Sixth Annual Assembly of the Kentucky District of the Pilgrim Holiness Church convened at 10:00 A. M., with the District Superintendent, E. E. Leadingham, in the chair. It opened by singing "Rock of Ages" and "Nearer, My God, to Thee." Prayer was offered by Brother F. W. May. "At the Cross" was then sung, and was followed by Scripture reading by Brother L. S. Houston, Luke 27:4-21, and Brother M. M. Benner, 1 Cor. 2: 23-30.

"Blessed Assurance" and "Nothing But the Blood" were sung, and were followed by prayer by Brother M. M. Benner. Communion was then served. A healing service followed and God came on the scene.

Brother Perry was appointed Secretary pro tem by Brother Leadingham, which appointment was approved by the Assembly.

Minutes of last Assembly were reviewed and approved.

Roll call was read.

Moved and supported that the first six seats shall constitute the Assembly Bar. Carried.

At this time Brother Leadingham presented six new churches to the Assembly: Louisville, with a membership of 17, Brother Shields, pastor; Fourth Church of Ashland with a membership of 14, Brother Rice, pastor; Tram with a membership of 15, Sister Ackerman, pastor; Central City with a membership of 16, Brother Fortner, pastor; Glancy Fork with a membership of over 20; and Stinson with 11 members, Brother M. F. Leadingham, pastor. A new mission at Frankfort with Brother Ezra McVey as pastor was also presented. The pastors and workers spoke of God's blessing in the building and organizing of these new places.

Moved and supported to receive these new churches into the District. Carried.

Moved and supported to give a rising vote of appreciation for the sacrifice of those who have been instrumental in establishing these new works. Carried, with the District Council shaking hands with those present, in behalf of the Assembly.

A letter of transfer for Brother Ezra McVey was read. Moved and supported that Brother McVey be received into our District. Carried.

By common consent the Assembly decided to have God's Bible School print the minutes this year.

Brothers F. W. May and Paul Stewart were appointed to serve on the reception committee.

Moved and supported that the time of the business sessions be from 8:30 A. M. to 12:00. Carried.

Moved and supported that we have a recess from 10:00 A. M. to 10:15. Carried.

Moved and supported that meals be served as follows:

Breakfast, 7:30; dinner, 12:15; supper, 5:30. Carried.

Moved and supported that the last clause of the former motion, concerning supper, be rescinded, and time changed to 5:00 P. M. Carried.

Moved and supported that the District Superintendent arrange for the evening services at 6:00 P. M. Carried.

Brother Waddell, District Superintendent of Kansas District, was presented to the Assembly.

Moved and supported that a rising vote of appreciation be given to him for his labors in our midst, and that he be given a seat on the platform with the privilege of the floor. Carried.

Brother Singleton from the Kansas District was presented to the Assembly and received into the district upon the recommendation of Brother Waddell.

Brother Walton of Colorado Springs, our missionary representative, was

presented to the Assembly and given a seat in the bar with the privilege of the floor.

Adjourned by a motion to meet at 8:30 Tuesday morning, August 6.

Second Sitting

August 6, 1935

Session opened by singing "At the Cross," followed by prayer by Brother L. S. Houston. Brother and Sister Alex Rice sang "He Knows the Way." Scripture lesson was read by Brother C. F. Shields, Prov. 3:1-10.

The roll was called and new delegates were registered.

The minutes of the last sitting were read and approved.

A motion was made and carried that Brother B. H. Lucas be received into our district from the Tennessee-Alabama District.

Brother F. A. Shull, from the Illinois-Missouri District, and Brother H. S. Martin, from the Indiana District, were presented to the Assembly, and each gave a word of testimony. A motion was made and carried to give these brethren an honorary seat in the conference bar.

The chairman appointed the following Committees:

Ways and Means—Brothers M. M. Benner, C. F. Shields, L. S. Houston.

Statistical—Brother Kenneth A. Brannon, Sister Alma Honeycutt.

Editing—Brother R. D. Perry, Sister M. A. Johnson, Sister Jenny V. Vincent.

Reports of churches were read as follows::

First, Second and Fourth Churches of Ashland reports were read and accepted. (Third Church reports not in.)

Aspen Grove reports were read and accepted.

Discussion as to whether the ministerial tithe should be paid through the local treasurer or to the district superintendent was before the Assembly. This was left flexible.

The chairman appointed the Resolution Committee as follows:

Brothers H. H. Bolender, B. H. Lucas, E. Honeycutt, J. Tackett and F. M. Singleton.

Brother R. V. Turner gave a verbal report from the Barterville church. It has been reorganized, and prospects are good for this year.

Reports of Carrollton church were read and accepted.

Adjourned for recess.

The Assembly reconvened while the Bowling Brothers sang "The Unsearchable Riches of Christ."

Reports of Central City and Cloverport churches were read and accepted.

The chairman appointed the following Committee on memorials:

Brother Leonard Bowling, Sister Lula Watson, Sister Anna M. Evans.

A motion prevailed that the election of officers be held on Wednesday at 9:00 o'clock.

First Church, Covington, reports were read and accepted.

A motion was made and carried that the name of the Latonia church be changed to Second Church, Covington. Reports of this church were heard and accepted.

Reports of Dalesburg church were read by the Secretary and accepted.

The District Superintendent reported that on account of not having collected sufficient funds to build the dormitory, and also on account of not being sure that Aspen Grove is our permanent Assembly and Camp Grounds, the building committee decided to hold the money collected, \$110.10, in the Treasury as a building fund.

A motion was made and carried that Aspen Grove be made a permanent home for the District Assembly and Camp.

A motion prevailed that the District Council make the necessary arrangements for entertaining the campers.

There was a motion made and carried that Prestonsburg be the place for our Ministerial Meeting this year.

It was moved that Resolution No. 20 be rescinded, and that the Resolution

Committee bring before the Assembly a Resolution drafted to take care of this matter more satisfactorily. Carried.

Elizabethtown reports were read and accepted.

Benediction by Brother Kenneth Fleming.

Third Sitting

August 7, 1935

This session opened by singing "I Will Make the Darkness Light." Brother J. M. Walton led in prayer, and after this the Trio from Covington sang, "I Have Found the Way."

The Scripture lesson was read by Brother L. L. Waddell, from Eph. 1:15-17, and his comments following it were very helpful and instructive.

The roll was called and the minutes of the last sitting were read and accepted.

As the order of the day was the election of officers, tellers were then appointed as follows:

Brothers M. M. Benner, L. S. Houston and R. D. Perry.

Moved and supported to have the report of the District Superintendent. This report was read and accepted by a rising vote.

Result of the election showed Brother E. E. Leadingham elected on the first ballot, receiving 52 out of 59 votes cast. A speech of acceptance was given and a special request was made to pray more for Brother Leadingham this year. A rising vote was given in response to this request.

Brother C. E. Posey was elected Assistant District Superintendent, receiving 43 votes out of 63 cast.

In the election for District Secretary, Sister Jenny V. Vincent received 48 out of the 62 votes cast.

Brother M. M. Benner received 55 out of 61 votes cast for the office of District Treasurer.

Moved and carried to extend the time of the session until the vote is taken for the 3 members of the Council, so votes can be counted during the recess.

Recess of 15 minutes was taken.

Sitting was reassembled and Brother W. C. Miller and daughter sang "You Will Have to Live Your Religion."

The count declared that Brothers L. S. Houston and H. H. Bolender were elected on the District Council; second vote was cast and resulted in the election of Brother P. O. Carpenter as the third member of the Council.

A motion was made and carried to suspend the rules and elect by acclamation all of the present Camp Meeting Committee, except the member who is absent. This was carried, and Brother Robt. Weedman was chosen as the additional member.

Brother L. S. Houston was elected by acclamation on the Examining Board.

Brother C. E. Johnson was elected by vote on the Educational Board.

Motion made and carried that Brother Earl Sorrell be the delegate from the Erlanger Church.

"A String of Empties" was sung by Brother Lawrence Steele.

A motion was made and carried that the rules be suspended and that the District Superintendent be elected by acclamation as the chairman of the Board of Trustees. The other two trustees elected were Brothers C. E. Posey and H. H. Bolender.

The memorials of our minutes were read and approved.

The following were elected on the Foreign Missionary Board:

Sister Jenny V. Vincent and Eddie Braam and Brother K. Brannon.

Brother W. C. Miller and daughter again sang "The Glory Land Special."

It was requested that Sister Marie Holmes sing "Some Things We Do Know."

A motion was made and carried that the chair appoint the Statistical and Auditing Committees.

After the announcements the benediction was pronounced by Brother Reuben York.

Fourth Sitting

August 8, 1935

The Assembly opened by singing "At the Cross," which was followed by prayer by Brother B. H. Lucas. The Scripture lesson was read from the Ephesian Letter, the 4th chapter. Brother Walton then sang "Heaven's Aristocrat" and "The Bride of Christ."

Roll was called and the minutes of the last session were read and approved.

The Auditing Committee, Brothers L. S. Houston, B. F. Durham and Paul Stewart, was appointed by the chair.

At request Brother R. D. Perry presented a course that he has arranged for the local preachers. Moved and supported that we as an Assembly approve of this course.

Some money was found, and by common consent it is decided to place this money in the Treasury if no owner is found.

Since the three members of the Educational Board are all on the Camp Meeting Committee it was moved and carried that they be taken off the latter Committee, and the chair appoint three others to take their places.

A song, "We'll Be Ready When the Train Comes In," was sung by Brother W. C. Miller and daughter.

A quartet sang "Beautiful Home Somewhere."

Our General Superintendent, W. L. Surbrook, was introduced to the Assembly and took the chair, coming from Denton, Md., Assembly.

Moved and supported to adopt the correction in Resolution No. 1. Carried.

Moved and carried to correct Resolution No. 3.

Resolution No. 4 was referred to the Committee.

Moved and carried to rescind Resolution No. 5.

It was moved and carried to add "straw ticks" to Resolution No. 6.

The correction in Resolution No. 7 was moved and carried.

A motion was made and carried to omit the recess and proceed with the business.

It was moved and seconded that the corrections on Resolution No. 13 be accepted. Carried.

It was urged that Resolution No. 16 be carried out and that the district buy a complete set of books for the Educational Board.

It was moved and carried that Resolutions No. 22 and No. 23 be revoked.

The Ways and Means Committee presented Recommendation No. 5, corrected.

It was moved and carried that it be accepted.

A motion was made and carried that a recess of 10 minutes be taken.

The Assembly reconvened and the song, "Constantly Abiding," was sung.

It was moved and carried to accept the combination of Resolutions No. 4 and No. 20 in a corrected Resolution.

Reports of the Examining and Educational Boards were received. It was moved and seconded that the recommendations be accepted. Carried.

The Reception Committee presented Sister E. R. Burkholder and two daughters, who are welcomed into the Assembly.

It was moved and seconded that 500 copies of the Minutes be printed. Carried.

Recommendation No. 2 of the Ways and Means Committee was presented in corrected form. It was accepted and carried.

Moved and seconded that Recommendations No. 8 and No. 10 be stricken from the minutes.

Recommendation No. 13 was presented, and in the second motion that was made it was carried to the table.

A motion was made to adjourn. Carried by standing.

The prayer of dismissal was offered by Brother E. E. Leadingham.

Fifth Sitting

August 9, 1935

"Blessed Assurance" and "At the Cross" were sung as this session opened. The singing was followed by prayer by Brother Jack Tackett.

The roll was called and ministers and deaconesses responded by stating how many subscriptions to the "Advocate" they would be responsible for. A goodly number, 294, were obtained.

The minutes were read and passed upon.

Our General Superintendent spoke briefly in regard to the Bible School at Owosso. He then presented graphs showing the increase in membership and other phases of the work. In presenting the Ministerial Benefit Association it was found that 22 desired to join.

Brother W. L. Surbrook read the Scripture Lesson from 2 Cor. 6:1-10, basing his message on it, from the outline, Your Fire, Your Field, Your Future.

The District Superintendent appointed the following committees (after it was moved and carried that he do so):

Statistical—Brothers K. A. Brannon and Paul Stewart; Sister Alma Honeycutt.

Camp Meeting (additional members to that committee)—Brothers E. W. McVey, B. Holland and Floyd Singleton.

Resolution—Brothers H. H. Bolender, C. F. Steele and Jack Tackett.

It was moved and seconded that we have the Ordination Service at this time. Carried.

The Assembly joined in singing "A Charge to Keep I Have," which was followed by Scripture Reading by Brothers M. M. Benner, L. S. Houston and E. E. Leadingham. Brother C. E. Posey led in prayer, and the following candidates were then ordained: Brothers L. Steele, K. A. Brannon, Frank May, Floyd Singleton and Paul Stewart. The song, "Rock of Ages," was then sung.

Brother and Sister E. F. Williams and Sister Paul B. Gilmore were presented by the Reception Committee. It was moved and seconded that these friends be given honorary seats in the conference bar. Carried.

The summary of the Statistical Committee was read and accepted.

Moved and carried to accept the correction in Recommendation No. 9 by the Ways and Means Committee.

Moved and carried to exclude Recommendation No. 13 from our minutes and to accept the new one given in its place.

Further Resolutions, Nos. 20, 21, 22, 23, 24, 25, 26, presented by the Resolution Committee, were accepted.

The Reception Committee presented Brother and Sister R. D. Poe, laymen from Ohio, and they were welcomed with a hearty amen.

It was moved to grant Brother A. W. Stowers First Year Minister's License, and Sister Alma Honeycutt Third Year Minister's License. Carried.

The Auditing Committee reported that they were well pleased to find the books correct and in excellent condition. The report was accepted.

Moved and carried that the District Treasurer's Report be accepted as read.

It was moved and carried that the District Treasurer continue sending out the monthly statements.

Ministers' and deaconesses' names were called and their correct addresses were listed.

Moved and seconded to receive Brother and Sister E. F. Williams into the District upon the condition that they get their transfer within 60 days. Carried.

It was moved and carried that the Council have the privilege of licensing other ministers after investigation, as they see fit.

The District is urged by the General Superintendent to buy books of Seth C. Rees' Life Story.

An offering was taken for the General Superintendent, while the song, "Sweet Bye and Bye," was sung.

"A Thermometer," made by Brother L. S. Houston to stimulate interest in raising the District budget and the Foreign Missionary offerings, was presented; and it was moved and carried that the District Superintendent see to having copies of this Thermometer printed for use in the churches.

It was moved and carried that the calling of the evangelist for the District Camp be placed in the hands of the District Council.

Motion made and seconded that we adjourn. Carried.

The benediction was pronounced by our General Superintendent, Brother W. L. Surbook.

RESOLUTIONS

1. Resolved: that we adhere strictly to Manual in giving credentials, in compliance with Sec. 141-147-149.

2. Resolved: that each pastor read all Resolutions of this Assembly to his congregation at the earliest possible convenience.

3. Be it resolved: that the District Superintendent make at least three trips over the district during the year.

4. Resolved: that each church supply the Camp with two each of the following: knives, forks, spoons, cups, saucers, plates, glasses and straw ticks.

5. Resolved: that each pastor of our district make a special effort to place a 1934 Manual in the home of each member of our church.

6. Resolved: that no pastor hold revivals off his charge without making satisfactory arrangements with his local church board, and then not more than two revivals during the Conference year, provided said church is supporting him.

7. Resolved: that no person be granted license to preach, or renewal of credentials, who does not believe in and practice the Bible doctrine of tithing.

8. Resolved: that all Resolutions be retained from year to year, unless revoked or revised by special act of the Assembly.

9. Be it resolved: that the books of the local churches be closed at the end of the month prior to the month in which the Assembly convenes.

10. Be it resolved: that we as a District set for our goal at least one church in every county in the State of Kentucky, and that we never stop until this is done or Jesus comes. This would give us at least 121 churches.

11. Since it is a matter of importance for the pastors of the District to attend the Assembly and Camp, be it therefore resolved that the pastor's support at the church where he is or has been serving as pastor shall continue over the two Sundays while he is attending said Assembly and Camp, providing he has not moved before Assembly.

12. Resolved: that no church elect a delegate to our District Assembly, who will not agree to stay through the entire Assembly.

13. We recommend that those pursuing the Study Course send for their home study questions early in the year, forwarding with their request sufficient postage to cover cost of correspondence.

14. We recommend that the District Assembly furnish the Educational Board with a complete set of books of the Preachers' Study Course.

15. Whereas, many of our pastors have not received sufficient financial support, be it resolved, therefore, that each local church appoint one prayer meeting night each month as "Donation Night," at which time foodstuffs and provisions shall be brought together for the pastor.

16. Whereas we, as ministerial brethren, as a majority, do not believe in the practice of foot-washing in our churches; and whereas a few of our ministers preach it as a necessity, and this causes a confusion in some of our churches and has led to serious conditions; and inasmuch as the Manual does not give it as an ordinance, be it resolved that we refuse to license ministers who preach it as a necessity; and that those who now preach it as such will cease to preach same.

17. Be it resolved: that our District Superintendent appoint a Statistical Committee for next year.

18. Be it resolved: that each church send a set of reports corrected and balanced with a duplicate by the pastor, and that copy of said reports be handed to the Statistical Committee not later than the first session of the Assembly.

19 Be it resolved: that the Camp Meeting Committee formulate a set of rules governing the conduct of campers in dormitories. These rules to be printed and posted in proper places.

20. Resolved: that we give our General Superintendent a rising vote of thanks for his excellent service.

21. Resolved: that we give our District Superintendent a rising vote of thanks for his untiring service.

22. Resolved: that we give a rising vote of thanks to each of the churches for so liberally donating produce to our Camp and Assembly.

23. Resolved: that we give a rising vote of thanks to the Camp Meeting Committee for their service during our Camp and Assembly.

24. Resolved: that we give a rising vote of thanks to our cooks, kitchen and dining room workers for the splendid meals prepared and for their service.

25. Resolved: that we give a rising vote of thanks to the local church and community for their splendid co-operation.

26. Resolved: that we give a rising vote of thanks to the Statistical Committee for their splendid service.

RECOMMENDATIONS OF THE WAYS AND MEANS COMMITTEE

1. We recommend that we adopt the system of raising Foreign Missionary money requested by the General Church Board as follows: that each church have a Weekly Prayer Service and that a Missionary Rally be held monthly on the Lord's Day, and at this service an offering be taken for Foreign Missions, same to be forwarded to the District Treasurer.

2. In order to raise our District and General Budget, we recommend that each church raise an amount equivalent to \$3.00 per member per year (except probationary members and children under 14 years of age), same to be paid monthly.

3. We recommend that the Secretary and Treasurer be paid a minimum salary of \$50.00 each year, same to be paid in equal monthly payments.

4. We recommend the adoption of the suggestions of our General Superintendent relative to the Sunday Schools of our District giving 10 cents per week for a Tent Fund, and that each church pay \$1.00 per month for Home Missionary work. We further recommend that each Sunday School throughout the District adopt the Birthday Offering plan, said offering to go toward the Tent and Home Missionary Fund.

5. We recommend that all active pastors and evangelists pay two-thirds of their tithe to the District Superintendent; all other licensed and ordained ministers to be assessed \$12.00 per year, same to be paid monthly. Failure to do so each month will call for the action of the District Council.

6. We recommend that the District Superintendent's salary be reduced to \$1,200.00 and that we grant him \$300.00 for traveling expenses.

7. We recommend that we pay 25 per cent of the assessment of the Laity to the General Budget and that the remaining 75 per cent be left in the District as a sinking fund, and in the event that sufficient funds are not received from the Ministerial tithes and assessments to meet the District Superintendent's salary, that the same be paid from the sinking fund.

8. We recommend that each church in the District be requested to send to the Assembly not less than \$2.00 to help defray the table expenses, 1936.

9. We recommend that each member of the Pilgrim Holiness Church of the Kentucky District pay 10 cents per year into the District Treasury, same to be held in trust as a General Assembly Expense fund.

10. We recommend that each church take a free-will offering for the District Superintendent on his regular visits, the same to be deducted from the \$300.00 he is allowed on his traveling expenses.

11. We recommend that each Sunday School send 50 cents per month to help defray Camp and Assembly expenses, same to be forwarded monthly to the District Treasurer.
