Direct Deposit is safe, convenient and easy. To take advantage of this service, please complete the authorization agreement at the bottom and return it with the distribution form. (Direct Deposit is available for cash distributions only.)
<ol> <li>Direct Deposit has many benefits:         <ol> <li>The benefit payment is deposited timelier – no mailing involved.</li> <li>It eliminates the possibility of a lost, stolen or forged check.</li> </ol> </li> <li>The benefit payment is deposited to your checking or savings account even if you're on vacation, away on business or ill.</li> <li>It saves you a trip to your financial institution.</li> </ol>	All you need to do is complete the distribution form and then:  1. Fill in the following information below:  a. Name  b. Social Security Number  c. Phone Number  d. Financial Institution name, address, account name  e. Routing Transit Number and Account Number  2. Mark the box to indicate the type of account in which the benefit payment will be deposited.  3. If you are requesting the distribution be deposited into your checking account, attach a voided check for verification of all financial institution information. If you would like to deposit the distribution into your savings account, please contact your bank for the correct Routing/Transit Number and your Account Number.  4. Sign and Date the form to authorize Principal Financial Group to deposit the funds into your checking or savings account.  5. Return this form along with the distribution form.

Once you have sent your distribution request form to us, you can check the status and details of the benefit payment by logging in to your personal online account at <a href="www.principal.com">www.principal.com</a> , through the Principal Financial Group login at <a href="www.wesleyanpensionfund.com">www.wesleyanpensionfund.com</a> or by calling Principal's automated phone system at 800.547.7754. Once the distribution is processed, you can confirm the deposit with your financial institution.
